### 1. Call to Order and Roll Call

### 2. Discussion/Action – Proposed Amendment to Title 16, Division 13.2, Section 1398.44 of the California Code of Regulations: Adequate Supervision Defined

Mr. Hartzell explained to the Board the Department of Consumer Affairs (DCA) requested the Board eliminate the inference in proposed California Code of Regulations (CCR) Section 1398.44(d)(8) language that physical therapist assistants may have any ownership interest in a professional physical therapy corporation. This request was put forward because the Acting Director for DCA perceived inconsistencies with prior discussions if the Board.

The Board concurred with DCA's request.
