2. Guidelines for Issuing Citations and Imposing Discipline, and Uniform Standards Regarding Substance-Abusing Healing Arts Licensees

The Guidelines for Issuing Citations and Imposing Discipline, and Uniform Standards Regarding Substance-Abusing Healing Arts Licensees (Guidelines) were brought back for consideration based on the motion of the Board at the November 6, 2013 Board meeting to incorporate the changes made with the passage of SB 198.

Elsa Ybarra directed the members to the DRAFT revisions incorporating SB 198 (Physical Therapy Practice Act) and other typographical changes to the Guidelines. The Board approved the revisions made as presented.

MOTION: To approve the Guidelines as amended and delegate to the Executive Officer the authority to adopt the proposed regulatory changes, as modified and if there are no adverse comments received during the public comment period and delegate to the Executive Officer the authority to make technical or non-substantive changes that may be required in completing the rulemaking file.

The meeting adjourned at 11:05 a.m.


