# PRESIDENT'S MESSAGE



#### **This Is Your Board – Let's Collaborate!** By Alicia Rabena-Amen, Board President

When I first became a licensed physical therapist in 1998, I remember mailing my requirements to, and receiving my wall license from, the Physical Therapy Examining Committee (PTEC). Soon after, PTEC was renamed the Physical Therapy Board of California (PTBC) and began to take steps to

remove itself from the oversight of the Medical Board of California.



Regardless of the name change, as a licensee I did not quite grasp what the function of PTEC or the PTBC was, other than to keep my license up to date. Being a member of the Board has greatly filled in those gaps. But I am quite aware that the function of the PTBC is still a mystery to many who hold a license, as well as to the consumers of California. This is why outreach to our community of stakeholders continues to be a PTBC focus.

The function of the PTBC is to protect the public from the incompetent, unprofessional, and fraudulent practice of physical therapy. While the main audience of this newsletter are consumers of California, the licensees and applicants can often be the best educators of the public by sharing what we know about the PTBC with patients, family, friends, and acquaintances. Even forwarding a copy of this newsletter or sharing it on social media can help inform both your colleagues and consumers about the PTBC.

Community outreach is not just a desire of the PTBC; it is part of our mandate. In 2019, PTBC also made outreach part of its strategic plan. With the diligent work of our Executive Officer Jason Kaiser, the PTBC has recently secured a much-needed outreach coordinator (Communication and Education Analyst) position, now held by April Beauchamps. Her responsibilities are numerous, and her vision is grand.

One goal is for the PTBC to visit every physical therapy (PT) and physical therapy assistant (PTA) program in California. I am happy to report we are making great progress: The PTBC is holding Board meetings at new campuses where it has not previously been, and PTBC staff visits multiple campuses as able throughout the year to deliver educational, legislative, and application presentations. From this outreach effort, the PTBC has received applications that are more complete and with fewer deficiencies, resulting in faster license issuance.

School presentations are giving future PTs and PTAs a glimpse of the PTBC's function. Students get excellent information about the PTBC and what it does even before they become licensed. Many students are attending and participating in Board meetings; however, we still need the collaboration of the public and our licensees. On behalf of the PTBC, we invite you to attend Board meetings and be part of the solutions to our challenging issues in the physical therapy profession.

Throughout the year, the PTBC receives inquiries from licensees regarding laws and regulations. You can bring your experiences and expertise to help guide conversation and contribute to policy. Let's do this together! Public comment is taken on every agenda item at Board meetings. There is also an agenda item for public comment on items not on the current agenda, as well as an agenda item to discuss possible items for future meetings if there are important issues impacting the profession that you would like the Board to consider.

PTBC consumers and licensees come from diverse backgrounds and bring a wealth of experience, involvement, and practice to the conversation. This is your Board–let's collaborate!

#### Do we have your email address?

Licensees are required to provide the Physical Therapy Board of California (PTBC) with an email address if the licensee has one. Email is an efficient conduit for sharing information between PTBC and its applicants and licensees. PTBC will be able to communicate regarding the status of applications, renewals, and requests for various PTBC services; provide law and regulation updates; and disseminate important PTBC news directly to each applicant and licensee—from the PTBC to your door (or email inbox). It doesn't get much easier! The PTBC hopes this accelerated delivery and exchange of information will decrease processing times in all aspects of the PTBC's programs and facilitate licensees keeping apprised of laws and regulations and PTBC activities. Moreover, with the transition to the BreEZe system, email will be the standard method of

communication. You can submit/update your email address using BreEZe or submit your address change with BreEZe. You may also submit your email address in writing to the PTBC—please include your name and license number.

# DO YOU WANT TO HOST A BOARD MEETING?



#### Who is the Physical Therapy Board of California?

The Physical Therapy Board of California (PTBC) is a government agency within the Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. The PTBC provides three principal types of consumer services: verifies education and background prior to licensure, provides information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

#### **Board Meetings**

Board meetings are mandated to three board meetings a year. Typically, the PTBC conducts four meetings a year in the areas of Northern and Southern California. Board meetings are usually two days long and the public is highly encouraged to attend.

#### **Benefits of Hosting a Board Meeting**

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voice heard on topics being discussed.
- Students and applicants can attend in between classes and learn how the PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

### Mission

To advance and protect the interests of the people of California by the effective administration of the Physical Therapy Practice Act.

### Vision

The standard for consumer protection in physical therapy.

# MY JOURNEY FROM PT APPLICANT TO PT STUDENT BY DEBBIE HANNA

My journey to physical therapy (PT) school started when I was in high school: As an athlete who went through PT due to a shoulder injury, I learned about and fell in love with the profession early on. I then attended San Jose State University and graduated with my bachelor's of science in kinesiology with an emphasis in rehabilitation science. I maintained a consistent 16-unit schedule, worked 20 to 30 hours a week, volunteered as often as I could, and stayed active in school clubs and activities. I knew getting into PT school was going to be tough (and it was), so I boosted my resume every chance I had.

Nonetheless, I was lucky enough to have amazing advisers and peers who gave me some of the advice I will share with you, the first being Physical Therapist Centralized Application Service (PTCAS) located at **ptcas.org**—make it your new best friend! It has lists of all the programs nationwide for PTs and physical therapist assistants (PTAs) and includes requirements for each program. It doesn't always tell you if a program has a supplemental application, so go directly to the school's website.

Second piece of advice: Do not be afraid to call the programs directly and set up tours or ask any questions you have. Each program has someone designated to handle those questions and are usually more than willing to help. I recommend making an Excel spreadsheet with requirements, deadlines, costs, pros/cons, and ratings of your top choices.

So now you've decided where you're applying and PTCAS just opened applications. Make an account right away and get familiar with the system. You can complete your application over the course of a couple weeks. Tip number three: It usually takes PTCAS about two weeks to process transcripts, letters of recommendation, and Graduate Record Examination (GRE) scores, so procrastination will not work. If possible, have your application fully ready to be submitted at least two weeks before the deadline for the schools (which can vary school to school).

Once you've submitted applications, fees, and supplemental applications, the waiting game starts. Some schools don't do interviews, but others do, and you should be prepared for either. So, grab a friend, a list of possible questions, and role-play. It might feel silly, but it helped me come up with good answers on the spot.

Overall, I applied to six schools: three in California and three in North Carolina. California's University of

the Pacific (UOP) and North Carolina's Duke University were my top choices: UOP because of the shortened length of the program, small cohort, and location, and Duke University because why not? The other schools were my back-up schools. The day before my interview with UOP (one of the remaining schools in California that still does interviews), I was rejected by two schools. It was a big blow. My dad gave me this little nugget of advice: "If you didn't get in, you weren't meant to be there: Put your efforts into where you're supposed to be and let those others go." I completed the UOP interview, felt amazing, and four days later got two more rejection emails. I was down to UOP and Duke. I ended up being accepted to UOP and immediately took the offer. Duke called later to respectfully reject me, but that was OK. After my interview day at UOP I knew I was meant to be here based on the friendliness, compassion, and support I felt between the students.

As I got close to my start date, UOP paired all the firstyear students with a second-year buddy. My buddy was fantastic and supported me as I got nervous to start school. Fast-forward two years, and we're about to leave for 26 weeks of clinical rotations. Which leads me to my "in PT school" tips:

- First, it is going to be hard to work a job while you're in class. We have class from 8 a.m. to 5 p.m. Monday through Friday.
- Second, you and your cohort will go through a crazy time together and you'll learn to appreciate each other for what you all offer.
- Third, PT school should not be a competition with your peers. I'm proud of my cohort for making sure we get through this together and for supporting one another through struggles and realizations.
- Fourth and finally, the tips for getting ready to be in clinic will have to come from your clinical instructors, professors, and friends.

With the right amount of passion, drive, and support, you'll be there in much less time than you think!

# PHYSICAL THERAPY WITHIN THE SOCIAL ECOLOGY OF OPIOID USE DISORDER by dr. todd davenport

According to the National Institute on Drug Abuse, opioid overdoses killed almost 2,200 Californians in 2017. Synthetic opioids, such as fentanyl, have demonstrated the greatest recent increase in number of deaths. However, iatrogenic opioids are responsible for the greatest number of deaths over time, and they are also a recognized gateway to opioid use disorder (OUD). As such, the role of physical therapists to address the opioid crisis has gained increasing attention within our profession.

The social-ecological model of health provides a view of the many spheres of influence (structural, relational, and personal) that affect health at each point along the causal pathway of a disease (Figure). All interventions described in tertiary, secondary, primary, and primordial prevention also can be characterized with the social-ecological model of health. These spheres of influence can be used to identify social, economic, political, cultural, and legal factors that either promote or inhibit a disease process which, in turn, can be used to target prevention programs. The social-ecological model of health can be used to better understand the wide range of influences on individual patient circumstances, experiences, and encounters with the medical system, It also provides a model for physical therapists who want to apply their expertise outside typical clinical settings, because findings from applying this model may suggest novel settings in which physical therapists (PTs) and physical therapy assistants (PTAs) can be influential in the prevention and treatment of OUD.



The social-ecological model of health consists of at least four nesting levels of influence:

- The intrapersonal domain comprises individual knowledge, attitudes, beliefs, and values.
- The interpersonal domain involves the impact of relationships between a given individual and people in their immediate environment, including family members, friends and other peers, and healthcare practitioners.
- The community domain of the model involves influences from civic structure, design, government, and community norms.
- The societal domain includes cultural, religious, legal/regulatory, and political institutions' influence on health.

An important corollary of the social-ecological model of health as applied to OUD is that PTs and PTAs are responsible to influence sociocultural and legal factors that exert pressure on the clinical encounter. The physical therapy profession is limited to address the opioid crisis without, in some way, acknowledging and addressing these dominant community and societal factors. Another important corollary to the model is that issues typically thought to be unassociated with health care are brought within the direct purview of PTs and PTAs and should be prominent on the public-advocacy agendas of physical therapy professional organizations. Careful consideration of local social, economic, political, cultural, and legal influences on health is necessary for physical therapists to be optimally responsible and effective advocates related to OUD.

Multiple opportunities for PTs and PTAs to meaningfully address the social ecology of OUD appear at various levels of the social-ecological model of health.

Processes within the intrapersonal domain may predict risk factors and health outcomes. These processes include health literacy, attitudes, and beliefs; health-related self-efficacy; and psychological and psychiatric characteristics. Processes within the intrapersonal domain often are the focus of patient/client evaluation and intervention by PTs and PTAs, such as exercise and cognitive-functional

interventions. At this level, physical therapy professionals should seek to understand patients' and clients' unique characteristics that require specific evaluation and intervention in OUD.


The interpersonal domain of the social-ecological model of health involves proximate relationships with others, which can influence both an individual's internal processes related to health and the individual's surrounding community. These relationships may include family, friends, peer groups, co-workers, social media contacts, and healthcare workers. PTs and PTAs commonly leverage the interpersonal domain of the social ecological model of health to provide intervention, health promotion, and prevention services. However, PTs and PTAs could increase their reach within the interpersonal domain through family and caregiver education, as appropriate, and health promotion through traditional and new media.

Community-level interventions can involve the development of coalitions between community organizations and groups, such as health care providers, schools, parenting support groups, youth and family health advocates, business leaders, policy makers and local government representatives. At this level, PTs and PTAs may collaborate to develop best practices that can be applied across sectors of the community, to develop educational materials and trainings, and to advocate for resources and programs to meet the needs of community members at risk for persistent pain or OUD. Examples of efforts at this level include **opioid safety coalitions** and organizing efforts by local government agencies, which often are broadly open to stakeholders from the community.

Prevention at the societal level is perhaps the holy grail of PTs and PTAs in population health, because it is the most difficult to conceptualize and implement for most individual clinicians. However, PTs and PTAs can leverage their numbers and resources in professional societies and political action committees in order to engage in socially responsive and responsible advocacy approaches that can change **political, regulatory, and cultural institutions that may fuel the opioid crisis.** These approaches may include criminal justice reform, as well as actions that reduce economic inequality and health disparities, reduce sources of extreme adversity in early childhood, reduce stigma around OUD, reform opiate prescribing practices, address payment barriers for OUD prevention and treatment, address barriers to physical therapists engaging in OUD prevention, and advocate for required training in OUD as part of relicensure requirements.

OUD is one of the most important health-related crises of our time, because of the challenges it has brought to California and elsewhere. It is important to recognize the social, economic, and political drivers of OUD, which is usually considered as an individual's medical problem. This recognition may be achieved through the application of population health frameworks like the social-ecological model of health, which can be used to describe various levels at which physical therapists can intervene through existing efforts and by developing new practice models.

Figure: Social-ecological model of opiod use disorder (OUD). An individual's health is nested within and depends upon factors at various levels, including the societal, community, interpersonal, and intrapersonal factors. Similarly, the development of OUD depends on the interplay between external barriers and facilitators and individual characteristics and behaviors.

# SUBSTANCE ABUSE REHABILITATION HOTLINE

Physical therapists (PTs) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10% of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including PTs and PTAs, may be particularly susceptible to substance-abuse problems due to the stresses of working in a health care environment and due to an increased opportunity to obtain controlled substances.

Many PTs and PTAs who experience problems with chemical dependency can find the help and support they need to stay clean and sober without involvement from the Physical Therapy Board of California (PTBC).

Unfortunately, most people suffering from chemical dependency deny the problem. Many times, they are the last to recognize and admit that they need help. If chemical-dependency problems are left untreated,

they may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted.

In these cases, it becomes imperative that individuals who detect a chemical-dependency health problem in a PT or PTA take action. Without intervention, diseases have predictable courses and outcomes. The PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

# A LICENSEE'S ROAD TO SOBRIETY

I wish to share my personal story with alcoholism and addiction for the sole purpose of serving and benefitting those on probation or struggling with addiction.

I was born and raised in the Midwest into a loving middle-class family. My parents divorced while I was young in elementary school. In the home I was raised, alcohol was acceptable in moderation, and, as an adult, drugs were tolerated. The first time I got drunk, I was barely a teenager. The first time I was arrested for an alcohol-related offense, I was a teenager just shy of 18 years old.

After high school, I moved hours away to attend a small college physical therapy program. I began to struggle in college with periods of binge drinking. On one occasion, I came to believe I had failed the semester. I responded by leaving school, making my way home where I proceeded to binge drink the entire break. I hadn't spoken a word of any of my concerns with anyone. Only after I returned to school from the break did I discover I had, in fact, passed.

In December 1998, I graduated with my degree and moved back home. As bouts of binge drinking continued, relationships with friends and family alike were greatly affected. I took no responsibility or accountability for my actions as I rationalized and made excuses for my behavior. Soon after, in August 1999, I decided I needed a change. Together with a few friends, I decided to move to California. Within six months of moving to Orange County, I received my first DUI (driving under the influence) charge. In turn, I took a restricted-driving license to and from a treatment program and work. At that time, I merely attended a few Alcoholics Anonymous meetings as required and managed to get a sponsor. Shortly after, having fulfilled my requirement, I alone made the decision to move to Los Angeles and broke all ties; however, untreated alcoholism would continue to affect my life in many forms, both personally and professionally, for years to come.

In 2013, alcoholism, addiction and substance abuse would ultimately lead to my divorce. I had every opportunity to step into sobriety, recovery with treatment, and clinical support. I continued to struggle with the first step of sobriety, which is to simply admit powerlessness and that my life had become unmanageable. In 2015, following an arrest as a result of my behavior, the Physical Therapy Board of California took notice to preserve public safety. I accepted a three-year probation with terms and stipulations upon my license in order to continue to practice as a physical therapist. For me, it was not until I repeated the same behavior, which ultimately led to my lowest point coupled with great consequence, that I was able to accept my powerlessness and unmanageability. I was able to begin to work the steps of a program of both sobriety and recovery in treatment through the support of an Alcoholics Anonymous sponsor.

It is my hope and sole intention that anyone reading my story who is able to identify with any of my behavior will be inspired to take a step as an act of faith: Speak with a trusted friend, attend a meeting, or make a call to the Maximus Inc. Program's Substance Abuse Rehabilitation Hotline at **(800) 522-9198**. No matter how small or insignificant this act may be, it all starts with one small act of faith. Lives change every day. Miracles happen every day. This story no longer has to be your story. Sobriety is the best gift I ever gave myself. We can go through life letting things happen or we can go through life making things happen. Be strong—choose the right path.

### P.T. SPOTLIGHT BY APRIL BEAUCHAMPS

Many times, physical therapists (PTs) will say that the most rewarding aspect of their profession is the ability to help people. They can help consumers with various health conditions recover without the need for surgery and/or medications, and many physical therapists use their expertise to go above and beyond by volunteering in their community.



The Physical Therapy Board of California (PTBC) recognizes Arthur Baudendistel, P.T., for his contributions to the profession of physical therapy and his community. His contributions include taking in students to teach physical therapy, speaking engagements at various schools

about the profession of physical therapy and how to become a physical therapist, volunteering at the Capitol PT Health Fair, coaching basketball and track, volunteering for the Boy Scouts of America, and coaching hikers of Yosemite's Half Dome. Baudendistel has given back to the community in so many ways, the PTBC was honored to sit down with him and hear all about his volunteer work:

#### How long have you been a physical therapist?

Since 1982, so for 38 years. I graduated from University of California, San Francisco.

### What made you decide to enter the profession of physical therapy?

I became a physical therapist mainly because I had an older brother, David, with muscular dystrophy and became part of the family team helping him with his physical limitations. My dad would take David and me to visit David's friends at various nursing homes. My dad became David's friends' surrogate dad, visiting them over a span of 40 years and treating them to such simple pleasures as pizza and soft drinks. Because of these many visits, I became very comfortable around individuals who were missing extremities, could barely speak, were wheelchair-bound, and so forth. I was accustomed to going into nursing homes and seeing teenagers living there with many older adults. I learned from an early age that I had much to be thankful for, such as living at home, having a healthy and athletic body, and being able to easily get around: things we truly take for granted. David eventually died in my arms at home when he was only 21 and I was 17. As I competed in track and field sports from junior high school to well beyond college, I always kept my brother in mind, dedicating my accomplishments to him. After attending American River College, I transferred to Sacramento State University. When the athletic counselor at Sac State, Sterling Ables, informed me of their pre-physical therapy program, I knew that was for me! I've never looked back. I went on to earn a physical therapy degree at University of California, San Francisco. I feel that physical therapy is the greatest profession. It is just as rewarding today to help people with their physical needs as it was when I treated my first patient at what was then American River Hospital in 1982.

### What schools have your provided clinical instruction for?

I take students from Sacramento State University, University of the Pacific, Fresno State University, UCSF, and Sacramento City College.

### How did you get involved with the PT students from Pennsylvania?

About 15 years ago a girl named Stephanie looked up my website. Her dad was the head of sea life at parks such as Sea World. On my website, she saw that I had a pool in my office and contacted me. She asked if she could do an internship with me through her school, which was Slippery Rock University in Pennsylvania. said yes, and then the school contacted me and I filled out a contract with them to do it. I did offer for her to stay with me and my wife so she wouldn't have to pay rent somewhere. At first, she declined and found a place to lease, but before she was to go back the owner told her they had someone else to lease the place. She ended up calling me and asking if she could take me up on the offer to stay with me. I said yes, and then after her clinical service was over the school contacted me again to ask if I would be willing to take other students. I said yes and have been doing it ever since.

### What made you decide to travel to the surrounding schools to speak to them about PT?

The school I went to speak at was the school mu kids attended. They went to Victory Christian School, and I would take some of my equipment with me and show the students how it worked. I also talked to them about what physical therapists do and what occupations cross over. I also let them know what curriculum would be beneficial for them to take in high school if they want to be a physical therapist and what college courses they would be required to take. I also got invited to speak at four different high schools after my first son was born four months early at 1 pound, 5.5 ounces. My wife and I were able to speak on pre-born child development and what systems still need further development before we were able to take our son home four months later. Of course, we brought our son, Paul, with us and the news clippings about him.

### What is your role in volunteering at the Capitol PT Health Fair?

I measure the hand-gripping strength of over 200 people annually. I let them know what the average grip strength is for their age and gender and how they compare to the norms. If they are weak, I teach them some exercises. If they lack mobility, I teach them how to stretch and how to avoid getting carpal-tunnel problems. If needed, I then follow up by faxing them home exercise sheets on what I was able to teach them.

### Is it difficult to find time to volunteer in everything you volunteer in?

It's not difficult to find time. I'm always busy and, if there is a need somewhere, I try to create the time to help out. It's a little easier now to find some free time since our last son is a physical therapist and now works at my office full time. I have cut out some district volunteerism, but I still run the Sacramento Valley private-practice owners' semiannual meetings.

### You have volunteered a lot of time to high school students who do track. Was track a passion of yours?

Yes. I ran in high school college, and post-college. I was 10th in the state of California in the mile both my junior and senior years. I still hold American River College's 4-mile-relay school record when my three teammates and I ran under 4:19 in 1977. I also came in sixth in the state for 5,000 meters my sophomore year while at American River College. I used to train at over 300 miles per month and I have run 10 marathons, always around 2 hours and 30 minutes. I have been able to still connect to the running community by treating coach Bob King's runners at Del Campo High School for the past 15 years. I also used to be a race director to put on races for the Muscular Dystrophy Association, Christian Team Ministries, and the community of Fair Oaks.

What would you say is the most rewarding part of being able to give back in all the ways that you do? I am a sentimental guy. It is always nice to get thanks from my previous students and volunteers and updates on their successes in getting into P.T. school and their careers. I also find it extremely rewarding helping the homeless as well.

#### Is there an instant that stood out in any of your volunteer work that made you think, "This is why I volunteer my time?"

Hearing back from my pre-PT students and from my past interns is always nice. I like it when they let me know that they got into PT school, and when the interns graduate and get their first PT jobs. It's nice that a lot of them still want to keep in touch. One gal from Slippery Rock brought back her whole family for me to meet and to hike with them in Yosemite.

### What made you decide to get involved in the Boy Scouts Royal Rangers?

Since my wife and I have three sons, we got our boys started in the church boys' scouting group. I started to volunteer with the 7- and 8-year-olds called Buckaroos. After a few months there, I then became the head of the Royal Ranger group. I did this for 12 years until I bought my own PT practice. I had to always put so many hours into the practice, that I no longer had the time to volunteer with weekly Rangers.

### What made you decide to coach basketball for 12 years?

I coached second-graders to high school students. I always loved basketball and still occasionally shoot hoops about once a month. I got my kids into youth basketball early and an opportunity came up for me to coach at my daughter's middle school, so that's how it started. My wife is extremely supportive with all my volunteer endeavors.

#### You have guided more than 100 people up Half Dome in Yosemite and have hiked it 16 times. Do you plan on continuing to guide more people, and do you have a goal on how many times you want to hike it yourself?

I thought I was done after 15, but then I got the bug to do it again, so for my 60th birthday, all of my kids came and some went and did it with me for my 16th time. It is a 17-mile hike with a climb of 4,500 feet. No, I don't plan on doing it again unless someone really wants me to with them or I get the bug to do it again. When I would do it, I usually do it in June where the days are longer because we like to plan it as a 12-hour day. My fastest time was 4.5 hours.

### CONTINUING COMPETENCY BY SARAH CONLEY

In the last issue of Progress Notes, you read about how and why the Continuing Competency (CC) Program came to be for the physical therapy profession through the Legislature for consumer protection. Now that we know how we got here and why, let's look at the development of the program components by the Physical Therapy Board of California's (PTBC) CC Task Force and how they are carried out.

When drafting regulations, the CC Task Force adopted fundamental concepts on which the CC requirements would be based:

- 1. The regulations shall, first and foremost, provide consumer protection.
- 2. The regulations shall promote continued competency of the licensee.
- 3. The regulations shall offer maximum simplicity and flexibility to licensees, course providers and the PTBC.

Here it is again: consumer protection, first and foremost. It is the PTBC's duty to facilitate CC courses and activities in which the content contributes to licensees' knowledge, skills, and abilities to safely practice physical therapy. While this is the primary directive, the Task Force was aware there were other considerations. CC was deemed necessary, but it was not intended to be punitive.

To achieve the balance between consumer protection and licensee flexibility, the PTBC adopted two pathways to obtain credit: Traditional and Alternate. The Traditional pathway includes all education courses approved through an agency recognized by the PTBC, and college coursework from an education institution accredited by the U.S. Department of Education or by the regulatory authority of any state. The Alternate pathway includes specific, pre-determined activities, not courses, that are approved by the PTBC. The Alternate pathway component of the program is why physical therapist and physical therapist assistant licensees have a continuing competency requirement and not a continuing education requirement.

While the Alternate pathway activities were developed and set forth in regulation by the PTBC, this is not the case for Traditional pathway education courses. If an education course is not from an accredited institution, it must be approved by the PTBC. The PTBC does not directly approve courses; it recognizes CC Approval Agencies. Once recognized by the PTBC, the CC Recognized Approval Agency is delegated the authority to approve education providers and courses for credit to fulfill the CC requirement in California. Like licensees, Recognized CC Approval Agencies are subject to audit by the PTBC to ensure they are appropriately carrying out the PTBC's delegation. Therefore, whether the Traditional or Alternate pathway, the PTBC maintains ultimate oversight over the CC courses and activities for California.

#### PTBC is eliminating the pocket license!

The Physical Therapy Board of California (PTBC) is making license verification more effective and efficient for consumers and licensees. Effective July 2020, the PTBC will no longer issue pocket licenses upon initial licensure or renewal. Pocket licenses may not reflect a licensee's current status as it may change within the two-year license period, and they do not display enforcement action taken against a license, if any. Current license status and enforcement action information is available on Department of Consumer Affairs (DCA) License Search, an online license verification system. Consumers, employers, or any interested party can access license information online 24 hours a day, seven days a week. You can access the DCA License Search system on the home page of the PTBC website at www.ptbc.ca.gov.




