Licensees are required to provide the Physical Therapy Board of California (PTBC) with an email address if the licensee has one. Email is an efficient conduit for sharing information between the PTBC and its applicants and licensees. The PTBC will be able to communicate regarding the status of applications, renewals, and requests for various PTBC services; provide law and regulation updates; and disseminate important PTBC news directly to each applicant and licensee—from the PTBC to your door (or email inbox). It doesn't get much easier! The PTBC hopes this

accelerated delivery and exchange of information will decrease processing times in all aspects of the PTBC's programs and facilitate licensees keeping apprised of laws and regulations and PTBC activities. Moreover, with the transition to the BreEZe system, email will be the standard method of communication. You can submit/update your email address using BreEZe or submit your address change with BreEZe. You may also submit your email address in writing to the PTBC; please include your name and license number.

Who is the Physical Therapy Board of California?

The Physical Therapy Board of California (PTBC) is a government agency within the Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. The PTBC provides three principal types of consumer services: verifies education and background prior to licensure, provides information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

Board Meetings

Board meetings are mandated to three per year. Typically, PTBC conducts four meetings a year in areas of Northern and Southern California. Board meetings are usually two days long and the public is highly encouraged to attend.

Benefits of Hosting a Board Meeting

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voices heard on topics being discussed.
- Students and applicants can attend in between classes and learn how PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

To advance and protect the interests of the people of California by the effective administration of the Physical Therapy Practice Act.

BENEFITS OF ATTENDING A BOARD MEETING

The Physical Therapy Board of California (PTBC) has four meetings a year in the areas of Northern and Southern California. Board meetings are typically two days long and can be watched online or seen in person. Watching the Board meeting online is an excellent way to stay up-to-date on issues having to do with the physical therapy practice, but as a licensee, student, or consumer, attending a PTBC meeting live can provide even more benefits.

For licensees, you can earn continuing competency credit for attending and are also given the opportunity to see how the Board operates and comes to various decisions regarding the practice of physical therapy. Laws and regulations are also discussed. During these discussions, public comment is encouraged. It is always beneficial to attend Board meetings when they are held in your area because it provides the opportunity to contribute ideas, express concerns, and share opinions on various issues, laws, and regulations that affect your profession.

As a student, you can see firsthand how the Board works and comes to decisions that will affect you in your career. You also can meet the Board members and PTBC staff. Attending a hearing regarding disciplinary action at a Board meeting gives you a unique opportunity to watch the disciplinary process up close. As a student, it is also a good idea to attend Board meetings in your area to gain a better

understanding and knowledge about the profession you are entering.

The PTBC advocates for the consumer, and consumer protection is its highest priority. As a consumer, the primary benefit of attending a Board meeting is the knowledge you gain of the profession. Consumers get the opportunity to learn what is going on in the profession, hot topics surrounding the profession, and have a chance to meet the Board members and PTBC staff. You can also have your voice heard on topics being discussed or gain clarity on topics you may not understand.

Licensees, students, and consumers are highly encouraged to attend Board meetings. SUBSTANCE ABUSE REHABILITATION HOTLINE

Physical therapists (PTs) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10 percent of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including PTs and PTAs, may be particularly susceptible to substance abuse problems due to the stresses of working in a health care environment and due to an increased opportunity to obtain controlled substances.

Many PTs and PTAs who experience problems with chemical dependency can find the help and support they need to stay clean and sober without involvement from the Physical Therapy Board of California (PTBC).

Unfortunately, most people suffering from chemical dependency deny the problem. Many times, they are the last to recognize and admit that they need help. If chemical dependency problems are left untreated, they may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted.

In these cases, it becomes imperative that individuals who detect a chemical dependency health problem in a PT or PTA take action. Without intervention, diseases have predictable courses and outcomes. The PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

PHYSICAL THERAPY PROBATION AND THE MAXIMUS REHABILITATION PROGRAM

A PERSONAL ACCOUNT FROM A LICENSEE IN RECOVERY

When I was asked to give my personal account of what it's like to be a licensed physical therapist (PT) on probation, I thought it was an excellent opportunity for me to be of service. My hope in writing this article is to provide some insight to the Board members, those who may be supervising probationers, and other PTs or physical therapist assistants (PTAs) currently on probation and/or in the Board's rehabilitation monitoring program (Maximus). Further, I hope this article reaches PT and PTA students so they can know what to expect if they find themselves in a similar situation such as mine. First, I think a little backstory on how I landed on probation and in the Maximus program is warranted.

For many years I struggled with untreated alcoholism. I was the binge drinking type of alcoholic. My troubles with alcohol came in the form of multiple DUI arrests and convictions. In all, I had five DUIs over a 10-year period ranging from 2002 through 2011. It took me a long time to surrender to my alcoholism. What I know now is that I wasn't a bad person, I was a sick person with untreated alcoholism. I had a hard time admitting I was an alcoholic because I could stop for a period of time and get my life together, only to have it come crashing down with another senseless spree. In addition, in my mind at the time, I couldn't be an alcoholic because I was relatively successful in all other areas of my life. From 2002 to 2005, I got two DUIs in another state. I was working as a PTA at the time and I avoided any board disciplinary actions because back then, PTAs did not have a license. Even though I avoided any work-related repercussions, my life was starting to unravel. I decided that I needed a change of scenery, and in 2006 I moved to California to start PT school. The demands of PT school kept my drinking at bay for a while but as I neared completion of the program, my drinking picked up again. In 2008, I got two DUIs

within a short period of time. Shortly after, I went to treatment. I completed a 28-day outpatient treatment program and started attending Alcoholics Anonymous (AA). It was during that time that I took and passed the PT Board exam. My license was denied.

I managed to stay "dry" for two and a half years. I was completely miserable during that time. I really wanted to drink. I was attending AA, but I struggled with Step 1 of the Twelve Step program. I knew my life was unmanageable, but still wasn't convinced I was an alcoholic. I knew I was going to drink again and that is exactly what happened. I got my last DUI in 2011. My PT license was denied for a second time. In retrospect, that last DUI was the best thing that happened to me. I was thoroughly convinced I was an alcoholic, there was no more debate. I was sentenced to six months in jail. When I got out of jail, I dove head first into AA. My sobriety date is April 5, 2011. I spent the next four years of my life doing everything AA. I got a sponsor, I took the 12 steps, I had commitments at meetings, I documented every meeting I attended, and I never turned down an AA request. I started attending a health care support group and I learned what needed to be done to have any chance of getting a license to practice. In 2013, I started random drug/alcohol testing on my own expense. I was told by other health care practitioners that I needed to start a paper trail and show provable sobriety when I applied again for licensure. I applied in 2013 and my

license was denied for a third time. I appealed the Board's decision and requested an administrative law hearing.

In 2015, my case was settled out of court and I was offered a stipulated settlement, which included five years of probation and enrollment in the Maximus rehabilitation monitoring program.

I think my situation might be slightly unique in that when I started probation and the Maximus program, I was really excited. I don't think this is the case for most people starting probation/rehabilitation. I was given an opportunity to finally start my career. I was and still am extremely grateful. I have been on probation now for four years. Last February, I completed the Maximus program. What I can tell you is that the transition into the Maximus program was relatively easy for me because I went into it with a strong foundation of recovery through AA and having four years of sobriety really helped me be compliant with the requirements. The requirements for the program are very parallel to my personal recovery program. For example, Maximus requires random drug testing, attending and documenting AA meetings, and attending a health care support group. I was already doing those things when I enrolled in Maximus. The only thing that was new was the requirement of having a supervising PT at work and having to provide

quarterly progress reports. Again, I was so grateful to be working that I don't view it as hardship in any way. I currently have one year left of probation. I continue to provide quarterly reports and I continue with random drug testing. If I stay compliant, I will complete the terms and conditions of my probation next summer.

What I would like to tell the new probationer is I completely understand if you are feeling overwhelmed with all the requirements. It is a lot to deal with right off the bat. However, if you are on probation you have a license. It took me years to get my license. Try to be grateful for the opportunity to change your life and at the same time the ability to continue practicing. Sobriety has not only changed my life, but it most likely saved my life. I try to remember that the Board's responsibility is to protect the public. When I look back on how I was living and my past behaviors, I wouldn't have given me a license either. I am so grateful to be sober and an active participant in my recovery. I am a much better PT, husband, father, and member of the community as a result of my sobriety.



Many times when asked, physical therapists (PT) will say that the most rewarding aspect of their profession is the ability to help people. They can help consumers with various health conditions recover without the need for surgery and/or medications. Many physical therapists use their expertise to go above and beyond by volunteering in their community.



For this newsletter, the Physical Therapy Board of California (PTBC) would like to recognize Kimberly Wong, P.T. Ms. Wong has been a physical therapist for over 25 years, and not only does she help with the fall prevention classes offered at the University of California, Davis, she played a role in helping to get those classes started.

Ms. Wong also volunteers as part of the health and wellness team for the Sacramento Mandarins, a competitive junior drum and bugle corps. The *Sacramento Bee* has referred to the Sacramento Mandarins as, "One of the best kept secrets of Sacramento." As part of the health and wellness team, Ms. Wong meets with participants ahead of time to perform health and wellness screens. Throughout training and the competition season, she is there to assist with injuries and give advice. She is one of four PT volunteers and says they are always looking for more medical experts to volunteer as well.

We interviewed Ms. Wong about her involvement in the fall prevention classes and the Sacramento Mandarins:

How long have you been a physical therapist?

"Over 25 years. I received my bachelor's in physical therapy at Fresno State University."

What made you decide to enter the profession of physical therapy?

"I knew I wanted to be in the medical field, but I didn't want to be a doctor or a nurse. When I was in junior college, I learned about physical therapy through the Regional Occupation Program (ROP). Soon after, I got a job as a PT aide

and then realized physical therapy was a great fit for me personally and as a career."

Was working with fall prevention always your passion?

"No. About a decade ago, a friend of mine who is the 'Fall Prevention Lady,' asked me to join her in getting training on an evidence-based fall prevention program called Stepping On. So the state of California sent both of us to Wisconsin to become 'master trainers,' then we came back to train others around the state."

What motivated you to focus on fall prevention and how long have you worked in this specific area?

"Years of my practice were in skilled nursing facilities and the geriatric population. I enjoyed working with seniors and so with that came the issue of falls. When I was approached about getting further training for fall prevention I was intrigued. With more baby boomers turning 65, fall risk grows; about one in four seniors fall a year and the total cost of fall injuries is over \$50 billion annually. The Stepping On fall prevention program took a while to get started in Sacramento. Initially, it was hard to find the right contacts within the hospitals or senior communities interested in starting the program. We were able to build a program at the hospital I work at, UC Davis Medical Center (UCDMC), through their Trauma Prevention Unit. UCDMC is in its eighth year of quarterly fall prevention classes where I am a regular guest speaker."

What do you wish people knew more about regarding fall prevention?

"Many falls are preventable! Just because you are getting older, doesn't mean you have to stop an activity due to the fear of falling. There are classes to improve mobility/balance via exercise, improve awareness, learn strategies to reduce tripping hazards and other preventative tools. The Sacramento area has a lot of workshops through hospitals, senior centers or senior living communities that are free or cost a nominal fee to attend."

How did you get involved in the volunteer work you do with the performing arts? “I grew up around the Sacramento Mandarins Drum and Bugle Corps since I was a child and was a performer for 10 years. Then I instructed/coached for many years, even while I was in PT school. A few years ago, the executive director of the Mandarins approached me to help start up a health and wellness program for this underserved area of sports medicine—the students are incredible athletes that are talented musicians and dancers too.”

How often do you volunteer and how long have you been volunteering? “I’ve been volunteering most of my PT career; I probably use two to three weeks of my vacation time annually. I’ve had the privilege over the years to travel 10 times to developing countries with Joni Eareckson-Tada’s Wheels for the World, using my PT skills to fit wheelchairs for the marginalized disabled—practical compassion in action. www.joniandfriends.org/ministries/wheels-for-the-world/

For the Mandarins, it varies throughout the year. Fall through spring, I volunteer one weekend a month, then summertime ramps up to three to five times a week. This past July, I met the corps in Texas and toured with them for a week.”

Is it difficult to find the time to volunteer while doing your work with fall prevention? “Not really since I space it out so they don’t overlap. But at times during the summer it gets tiring when I go after work to do health and wellness with the drum corps. We (and other corps nationwide) definitely need more medical professionals to help join our health and wellness teams either locally or on the nationwide tour.”

For those who do not know, who are the Sacramento Mandarins? “It’s 154 students ages 15 to 21 who audition in the winter to make up this specialized marching band consisting of three sections—brass, percussion and color guard. They go through a grueling month-long spring training program that have rehearsals that last up to 14 hours a day to learn a single 10- to 12-minute show production. They refine the show as they travel for seven to eight weeks to compete against other corps across the country in football stadiums. Mandarins toured extensively in Northern and Southern California, over 35 states, and competed recently at events in San Antonio, Texas,

Atlanta, Georgia, Allentown, Pennsylvania, and ended August 10 at the DCI World Championships in Indianapolis, Indiana.

What is your role in volunteering with the performing arts/touring drum and bugle corps? “I am the health and wellness (H&W) co-director. I help in building the H&W team and appropriate policies and procedures. Also, I work with the administration and coaching/instructional staff to see what the needs of the students are regarding physical fitness, proper conditioning, healthy diet and mental health. I also perform the physical screenings (strength and flexibility) once a month at the winter weekend camps. During spring training, I help with the overuse injuries—providing basic first aid and exercises to help them recover.”

What would you say is the most rewarding part of being able to give back like this? “Seeing the students out there performing and doing what they love. They strive for excellence and now rank 10th worldwide. It’s cool—I can meld my professional skills with my passion for drum corps.”

Is there an instant that stood out and made you think, “This is why I volunteer my time”? “Last year during the championship week at the last rehearsal, the head instructor said, ‘Look, no one is in knee braces,’ and it was neat because it made me think, wow, we are making a difference. Also, the thanks we get from individual members makes it all worth it.”

What do you wish other people knew about touring drum and bugle corps? “Drum corps is a valid sport and they are artists too. The students are some of the most motivated clients eager to learn and do what you want to teach them and are appreciative. It is an underserved area of sports medicine and it needs more PTs, athletic trainers, nurses, and other medical practitioners to help volunteer (there are 10 corps in California alone—hint, hint).”

'THERAPIST OF RECORD' AND 'HAND-OFF' PROCEDURE

What is the role and responsibilities of the therapist of record for any given patient?

Through the course of physical therapy treatment, each patient will have a physical therapist identified as their therapist of record. What is the role and responsibilities of the therapist of record for any given patient? Can the therapist of record for the patient be transferred to another physical therapist?

Physical therapy is provided for patients and clients in many different settings and the contemporary practice of physical therapy quite often requires the physical therapist to use assistive personnel during the patient's episode of care. In this case, the physical therapist and the physical therapist assistant will work as a team to ensure safe and effective physical therapy services are delivered to the patient/client. However, in many cases, a different physical therapist may become involved in the patient/client's care. Subsequent to the initial evaluation, physical therapy services may occur by using per diem or a "pool" of physical therapists from the department (or clinic). Supervision of the physical therapist assistant will be affected if there is a change in the therapist of record for the patient. Because of the changes in personnel providing care, the clarification of who is the therapist of record and the use of a "hand-off" arrangement is very important. Due to the ramifications of using multiple physical therapists to provide the services during the patient/client's episode of care relative to the therapist of record, the "hand-off" procedure needs to be fully understood.

The Business and Professions Code (B&P) and California Code of Regulations (CCR) related to the practice of physical therapy identify the roles and responsibilities for the physical therapist and physical therapist assistant and establish who is responsible

for the patient care—identified as the therapist of record. It is important to highlight and clarify several items identified in the B&P and the CCR.

WHO IS RESPONSIBLE FOR THE PATIENT/CLIENT?

First and foremost, the physical therapist is responsible for managing all aspects of care for the patient/client. The physical therapist determines the breadth and depth of the physical therapy intervention and whom may provide the service. The type and quality of physical therapy services provided to the patient is the responsibility of the physical therapist. **(B&P §2622 (a), 16 CCR §1398.44 (a))**

WHO IS THE THERAPIST OF RECORD?

The therapist of record is identified in regulation as the physical therapist who performs the initial evaluation of the patient/client. This physical therapist continues as the therapist of record until this role/responsibility is reassigned (handed-off) to another physical therapist. **(16 CCR §1398.44 (b))**

WHAT IS THE ROLE/RESPONSIBILITIES OF THE THERAPIST OF RECORD?

The therapist of record supervises and provides direction to the physical therapist assistant if they are involved in the care of the patient. It is especially important that the physical therapist assistant knows who the therapist of record is for the patient and must have the ability to communicate with that therapist of record at all times during the treatment of the patient. **(16 CCR §1398.44 (c))**

WHAT IS A HAND-OFF PROCEDURE?

As mentioned earlier, the therapist of record is the physical therapist who performed the initial evaluation of the patient. However, the role/responsibility of the therapist of record can be transferred to another physical therapist. This reassignment of the therapist of record occurs through a process known as a hand-off procedure. The original therapist of record must ensure that a written system of transfer (the hand-off procedure) identifying who will be the new therapist of record is in place. (16 CCR §1398.44 (b))

In many clinical settings, the use of multiple physical therapists in providing care for the patient during their episode of care is commonplace. In these cases, the identification of the therapist of record and the procedure involved in any transfer of therapist of record to another physical therapist should be established in writing in the policy and procedure document of the practice setting. It is important to note that the specific procedure of how the therapist of record is transferred, if needed, can vary depending on the clinical setting. It is very likely to be different between an acute-care setting versus an out-patient setting. For example, in the acute-care setting, if therapist “A” performs an evaluation of a patient during a weekday (for example, on a Friday) but is not working when services are provided over the weekend, who is the therapist of record when weekend treatments are rendered? In the out-patient setting, a staff physical therapist may have a day off.

Subsequently, a physical therapist from the clinic’s personnel “pool” or a per-diem physical therapist from a registry company may perform an evaluation of a new patient when covering for the staff physical therapist. Upon returning from their day off, the staff physical therapist resumes with their case load, now including the new patient who was evaluated by the pool physical therapist or the per-diem registry physical therapist. Clarification of who is the patient’s therapist of record must occur. The examples given above are for the acute-care setting and the out-patient setting. However, in all practice settings, the identification of the therapist of record needs to be established. Additionally, it is especially important if the use of a physical therapist assistant is involved during the patient’s episode of care. The physical therapist assistant must be able to identify and communicate with the therapist of record in the event

they need guidance or report any change in the patient’s condition during their encounter with the patient.

For more information, the following are selected Business and Profession Codes and regulations related to this issue and address this area of physical therapy services (*emphasis added*). (Note: section (d) of 16 CCR 1988.44 was not included for brevity.)

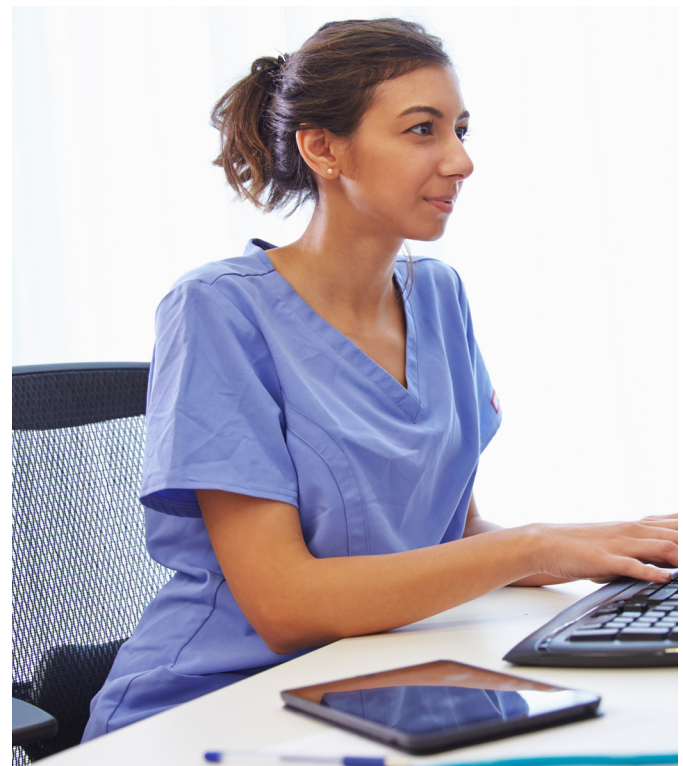

CONTINUING COMPETENCY BY SARAH CONLEY

Competency. What does this mean to the physical therapy practice, and what does it have to do with consumer protection? Applicants for initial licensure are required to demonstrate minimum competency to practice or assist in the provision of physical therapy by passing the National Physical Therapy Examination (NPTE). The NPTE is the measure used to determine minimum competency and ability to safely practice on consumers. What about ongoing competency five, 10, 20 years into practice? While little can compare to on-the-job, experienced-based competency, is that enough to ensure consumers are getting the most up-to-date care? In 2004, the Citizens Advocacy Center stated the following regarding continuing competence:

“Patients have every right to assume that a health care provider’s license to practice is the government’s assurance of his or her current professional competence, and clinicians themselves would like assurance that those with whom they practice are current and fully competent. Unfortunately, this is not the case.”

In 2006, the California Legislature concurred. Assembly Bill 120, authored by former Assembly Member Rebecca Cohn and sponsored by the California Physical Therapy Association, codified that the Physical Therapy Board of California (PTBC), the regulator of the profession who is charged with consumer protection, shall establish a continuing competency program for its licensees. This action was preceded by the Federation of State Boards of Physical Therapy (FSBPT) release of the Standards of Competence—this document outlined recommended continuing competency standards developed after an extensive, nationwide study and review of the topic. With its new continuing competency charge, the PTBC established a task force to develop the program; the task force referenced the FSBPT’s study, among other materials, in developing its recommendations. Those recommendations ultimately adopted by the Board are recorded in California Code of Regulations, Title 16, sections 1399.90–1399.99. While the PTBC has a well-established continuing competency program for the licensees of California, continuing competence was and remains a nationwide topic of discussion. Look for more articles related to continuing competency in the next issue of *Progress Notes*.
