Licensees are required to provide the Physical Therapy Board of California (PTBC) with an email address if the licensee has one. Email is an efficient conduit for sharing information between PTBC and its applicants and licensees. PTBC will be able to communicate regarding the status of applications, renewals, and regulation updates; and disseminate important PTBC news directly to each applicant and licensee—from the PTBC to your door (or email inbox). It doesn't get much easier! The PTBC hopes this accelerated delivery and exchange of information will decrease processing times in all aspects of the PTBC's programs and facilitate licensees keeping apprised of laws and regulations and PTBC activities. Moreover, with the transition to the BreEZe system, email will be the standard method of communication. You can submit/update your email address using BreEZe or submit your address change

with BreEZe. You may also submit your email address in writing to the PTBC—please include your name and license number.

Who is the Physical Therapy Board of California?

The Physical Therapy Board of California (PTBC) is a government agency within the Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. The PTBC provides three principal types of consumer services: verifies education and background prior to licensure, provides information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

Board Meetings

Board meetings are mandated to three board meetings a year. Typically, the PTBC conducts four meetings a year in the areas of Northern and Southern California. Board meetings are usually two days long and the public is highly encouraged to attend.

Benefits of Hosting a Board Meeting

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voice heard on topics being discussed.
- Students and applicants can attend in between classes and learn how the PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

To advance and protect the interests of the people of California by the effective administration of the Physical Therapy Practice Act.

STAYING CONNECTED BY APRIL BEAUCHAMPS

Staying connected with the Physical Therapy Board of California (PTBC) is so important as an applicant, licensee, and consumer. Times change and so do policies, laws, regulations, general information, processes, and things related to the Physical Therapy Practice Act. Stakeholders can stay connected with PTBC by visiting our website regularly, following PTBC's social media accounts, and by joining our interested parties email list.

For applicants, it is important to first follow PTBC on social media, join our interested parties list, and check our website often. Applicants can get information on how to apply, the National Physical Therapy Exam (NPTE), the California Law Exam and study guide, and application processing times. They can also obtain information on anything about PTBC and, most importantly, the laws and regulations that govern the profession.

Once licensed, it is even more important to stay connected with PTBC. As stated before, laws and



regulations are always changing and/or new ones are being added. Not knowing a law or regulation and violating it can put your license in jeopardy. Staying connected with PTBC is the best way to ensure staying up to date on new and changing laws and regulations. Ignorance of the law is never a valid excuse for violating a law or regulation. By staying connected with PTBC, licensees will be notified whenever changes occur and will also be notified of any proposed regulations that they can provide input on before it takes effect. Remember, regulations have the same effect as a law, and failure to complu with either could result in an administrative action. As a licensee, you are responsible for keeping up to date with the laws and regulations that affect your licensure. To do this, you should follow PTBC on social media, check our website regularly, join our email blasts, and make sure your email is always current.

Staying connected as a consumer is just as important as staying connected as an applicant and licensee. Knowing the level of care you are receiving is extremely important. PTBC's mandate is consumer protection. Staying connected with PTBC ensures that consumers are receiving pertinent consumer protection information, updates, licensee information, and education to prevent being a victim of unsafe or unqualified services. By visiting the PTBC website, social media accounts, and joining our email blasts, consumers can learn about the laws and regulations that govern the physical therapy profession.

PHYSICAL THERAPIST/PHYSICAL THERAPIST ASSISTANT LICENSE APPLICANT STATUS BY SARAH CONLEY

Physical therapist and physical therapist assistant license holders apply to the Physical Therapy Board of California (PTBC) for the privilege to practice. This application process allows PTBC to thoroughly evaluate each applicant's minimum competency and ability to safely interact with the public, specifically California physical therapy consumers. Ensuring that only qualified and safe physical therapist and physical therapist assistant applicants are granted the privilege to practice is the first step in PTBC's consumer protection mandate as set forth in **Business** and Professions Code (BPC) section 2602.1. Workina in concert with BPC section 2602.1. BPC section 2639 sets forth that PTBC shall issue a temporary license to applicants. Temporary licensure provides applicants the opportunity to work under the supervision of a California licensed physical therapist as outlined in title 16, CCR sections 1399.10 and 1399.12 pending the results of their first attempt at the National Physical Therapy Examination (NPTE) and the issuance of a full privilege license. PTBC refers to temporary licensure as Physical Therapist License Applicant or Physical Therapist Assistant License Applicant status (PTLA/PTALA).

To qualify for PTLA/PTALA, an applicant must have submitted a complete licensure application form (electronic or paper) to PTBC and the applicant's education program must have confirmed the applicant's program completion with PTBC. Physical therapy education programs may confirm anticipated program completion with PTBC's examination vendor, the Federation of State Boards of Physical Therapy (FSBPT), to allow students to sit for the NPTE, but PTBC requires confirmation that the student has completed a program for PTLA/PTALA status. In addition to the application form and education verification, an applicant shall not have a criminal history. If an applicant has a criminal history, the PTBC Consumer Protection Services (CPS) program must evaluate the application before PTLA/PTALA is granted, if at all. PTBC obtains criminal history information from the Department of Justice and FBI via applicant fingerprint submission.

PTLA/PTALA status may be granted to applicants who qualify at various times throughout the application process—when PTBC initially accepts the application (commonly referred to as Intake), when the assigned analyst evaluates the application, or any time during the application process PTBC receives required information and/or documentation and the applicant qualifies. Once granted, PTLA/PTALA status is valid for 120 days pending the results of their first NPTE attempt. If an applicant achieves a passing score on their first NPTE attempt, PTLA/PTALA status remains in effect until your license is issued or denied. PTLA/ PTALA status terminates immediately in the event that any of the following occurs: The applicant does not achieve a passing score on their first NPTE attempt, the applicant does not attempt the NPTE and the 120-day period expires, or PTBC receives criminal information not already considered when PTLA/PTALA

status was granted. As mentioned earlier, PTLA/ PTALA status must comport with PTBC's primary mandate of consumer protection, so it is only granted under specific provisions for a limited time and is not extended or reinstated. It is both the responsibility of the applicant and the applicant's supervisor to be aware of the PTLA/PTALA status practice and supervision requirements, including when PTLA/PTALA status may terminate during the application process. Both the applicant and supervisor shall maintain communication regarding the applicant's PTLA/PTALA status standing. PTLA/PTALA status information is posted to applicants' BreEZe account as well as being emailed directly.

PROBATION MONITOR Q&A BY MONNY MARTIN



1. How is a P.T. or PTA placed on probation?

A P.T. or PTA is placed on probation for violating the Physical Therapy Practice Act. Their license is revoked for the violation, but the revocation is stayed and the P.T. or PTA is placed on probation with terms and conditions for a period of time. An applicant may also be granted an Initial Probationary License for criminal convictions that occurred before they were licensed.

2. What happens if you are put on probation?

If a licensee is placed on probation, their license is restricted for a period of time. If they want to keep their license they must agree to practice under various terms and conditions of probation and pay any associated fees.

3. What do you have to do when you are put on probation?

When a licensee is placed on probation they agree to practice by certain terms and conditions. Many times, a licensee's practice is restricted in multiple ways, such as being required to have a supervising physical therapist, not being able to supervise assistive personnel, needing to have their documentation reviewed by a supervising physical therapist, or not being allowed to work in home health. These are just a few of the restrictions a licensee may encounter while on probation.

4. Can you petition the Board to change its decision when put on probation?

There is a process for a Petition for Reconsideration if you have been put on probation as a result of a hearing. If the licensee has been put on probation following a Stipulated Decision and Order, there is no process to petition the Board's decision.

5. What is Maximus?

Maximus facilitates the Drug and Alcohol Recovery Monitoring Program for PTBC. The program is confidential and provides monitoring and rehabilitation of health care professionals whose ability to practice safely has been affected by the use of drugs or alcohol, and in some cases, by mental illness. The primary mission of the program is equal to that of PTBC's, which is to protect the public and return the participant to safe, professional practice. Treatment followed by supportive monitoring **reduces the risk of relapse to less than 20%**.

6. Does Maximus cost anything (monetary/time)?

Yes, not only can Maximus be expensive, it is also time consuming. The costs associated with the PTBC's recovery program vary depending on different factors, but you can expect to pay a monthly fee, as well as fees for drug testing, and fees for health support groups. A complete breakdown of all costs can be found on the Board's website here: **www.ptbc.ca.gov/licensees/diversion.shtml.** It normally takes a minimum of three years to

successfully complete the program.

7. Are there extra costs for being on probation?

When a licensee is placed on probation, they may be responsible for reimbursing PTBC the costs to investigate their case. They will also have to pay probation monitoring costs. The current cost is \$100/quarter but is subject to change.

8. Can a licensee still practice while on probation?

Yes, and that is the expectation. We want to monitor the licensee while they are working. Probation orders require the licensee to work a minimum number of hours (192) in a three-month period to receive credit toward completing probation. If the licensee doesn't work the minimum number of hours required, their probation term may be extended.

9. How is a licensee's probation monitored?

Licensees on probation are required to report to PTBC's probation monitor. The licensee is required to submit quarterly reports and possibly other documents, and meet/speak with their monitor for quarterly interviews.

10. How many times does the probation monitor meet with a licensee?

Licensees are required to participate in quarterly interviews with their probation monitor but may be required to meet more frequently as needed.

11. Does the licensee need to let the consumer know that they are on probation?

Depending on the types of violations, some licensees are required to notify all patients that their license has been placed on probation.

12. How can a consumer find out if and why their P.T. or PTA is on probation?

It's easy. Disciplinary actions pertaining to licensed physical therapists and physical therapist assistants are at <u>https://search.dca.ca.gov</u>. All you need to do is search for them by name. That will also show if the licensee was previously on probation if they aren't currently.

13. If a licensee was put on probation, is the complainant made aware that the licensee was placed on probation?

Yes, complainants are notified of the outcome of the investigation.

14. How long must a person be on probation before they can petition the Board to have probation lifted?

All orders for probation are different. When a licensee can petition for modification or early termination of their probation depends on their particular disciplinary order. Most licensees on probation must successfully complete a minimum of two years before they can petition to have their probation terminated.

MEET ELSA YBARRA, PTBC'S ASSISTANT EXECUTIVE OFFICER



1. How long have you worked for PTBC?

I started my state service with PTBC in August 1990 and there was a total of five staff, including the executive officer. Yes, it's been a long time!

2. What was your first job title at PTBC?

I started out as an office assistant—it entailed opening mail, processing applications, answering phones, issuing licenses, and anything else that was handed to me.

- **3. What is your favorite color?** Purple.
- **4. What is your favorite food?** Chinese.

5. When you were a kid, what did you want to be when you grew up?

I believe it was a teacher, but I also had an interest in law. I didn't follow either of those paths, but I did end up in a position with the Board that took some of that interest in law.

7. What is the furthest place you have ever traveled to?

My husband is retired from the Air Force and so I had the opportunity to travel in Europe since we were stationed in Italy for four and a half years. While stationed in Italy, we visited much of Italy, but also Germany, England, France, Greece, and Netherlands. It's been quite some time since we were in Europe but we do plan on returning soon—hopefully! Right before the pandemic hit, I traveled to the Dominican Republic. I'm hoping that things open up soon to once again travel safely.

8. What is the most exciting place you have ever traveled to and why?

I would have to say Europe. I couldn't say that one country was more exciting than the other because it was all exciting and an adventure in itself. 9. What does the assistant executive officer (AEO) do for PTBC?

schools develop, which has a trickling effect on the workload and has increased the number of staff. The AEO manages the daily operations of the Board. The AEO responsibilities alleviate the daily routine functions from the executive officer (EO) and allows him to focus on the higher-level matters that affect the Board. As the AEO, I'm under the direction of the EO. My responsibilities include the day-to-day administrative functions, which include the oversight of Board programs. I work with managers in Application and Licensing, Consumer Protection Services, and Administrative programs making sure that their programs are running efficiently. I'm still very involved with the Consumer Protection Services Program. I provide guidance to staff and review cases in preparation for the EO's final approval on disciplinary actions. I consult with the EO on issues affecting the programs, the effectiveness of the programs, sensitive issues, legislative and regulatory concepts, budget, and anything and everything affecting the Board.

10. What was your position before becoming the AEO and for how long?

I managed the Consumer Protection Services Program for five years.

11. What does the Consumer Protection Services Program do and why did you like it?

The Board regulates the practice of physical therapy and is required to enforce the Physical Therapy Practice Act. Its highest priority is public protection. The Consumer Protection Services Program receives complaints alleging unlicensed practice, unprofessional conduct, sexual misconduct, and other matters regarding the practice of physical therapy. Board staff investigate complaints but also use the Department of Consumer Affairs' Division of Investigation (DOI) to conduct formal investigations. Cases are referred to DOI requiring interviews and to obtain documents that staff do not have access to. If the investigation confirms a violation of the Physical Therapy Practice Act, the Board may take administrative action by citing the licensee, but depending on the level of the violation, the case can be transmitted to the Office of the Attorney General for disciplinary action resulting in probation, revocation, or surrender of their license. This is a very brief description of the investigative process, but the Consumer Protection Services Program serves a very important role within the Board.

It's an interesting program to work in. What I mean by that: The work involved is broad and it's up to you as the analyst to ensure that you've touched on and made every effort to determine if there is merit to the allegations and then lead that investigation to gather the necessary evidence. This could include your own research on issues, requesting documents from various agencies, and following up with questions, working with the DOI investigators, and P.T. expert consultants. The investigative process could get frustrating and stressful because there's always obstacles that cause delays or make it difficult to obtain the necessary evidence for the Board to act on, but that makes you that much more determined to complete the investigation.

At the end of the day, or at the closure of your case(s), you hope that the resolution was appropriate and fulfills the necessary consumer protection.

12. What is your favorite thing about working for PTBC?

I've been with PTBC for so many years! That alone speaks for itself. But I work, and have worked, with an amazing staff. Staff are dedicated with a team spirit in meeting our consumer needs, and there's always a team environment that truly makes this a great place to work. That's why I enjoy working for PTBC.

SUBSTANCE ABUSE REHABILITATION HOTLINE



Physical therapists (P.T.s) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10% of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including P.T.s and PTAs, may be particularly susceptible to substance abuse problems due to the stresses of working in a health care environment and due to an increased opportunity to obtain controlled substances.

Many P.T.s and PTAs who experience problems with chemical dependency can find the help and support they need to stay clean and sober without involvement from the Physical Therapy Board of California (PTBC).

Unfortunately, most people suffering from chemical dependency deny the problem. Many times, they are the last to recognize and admit that they need help. If chemical dependency problems are left untreated, they

may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted.

In these cases, it becomes imperative that individuals who detect a chemical dependency health problem in a P.T. or PTA take action. Without intervention, diseases have predictable courses and outcomes. The PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

PTBC is eliminating the pocket license

The Physical Therapy Board of California (PTBC) is making license verification more effective and efficient for consumers and licensees. Effective July 2020, the PTBC will no longer issue pocket licenses upon initial licensure or renewal. Pocket licenses may not reflect a licensee's current status as it may change within the two-year license period, and they do not display enforcement action taken against a license, if any. Current license status and enforcement action information is available on Department of Consumer Affairs (DCA) License Search, an online license verification system. Consumers, employers, or any interested party can access license information online 24 hours a day, seven days a week. You can access the DCA License Search system on the home page of the PTBC website at www.ptbc.ca.gov.
