Do We Have Your Email Address?

Licensees are required to provide the Physical Therapy Board of California (PTBC) with an email address if the licensee has one. Email is an efficient conduit for sharing information between PTBC and its applicants and licensees. PTBC will be able to communicate regarding the status of applications, renewals, and requests for various PTBC services; provide law and regulation updates; and disseminate important PTBC news directly to each applicant and licensee—from the PTBC to your door (or email inbox). It doesn't get much easier! The PTBC hopes this accelerated delivery and exchange of information will decrease processing times in all aspects of the PTBC's programs and facilitate licensees keeping apprised of laws and regulations and PTBC activities. Moreover, with the transition to the BreEZe system, email will be the standard method of

communication. You can submit/update your email address using BreEZe or submit your address change with BreEZe. You may also submit your email address in writing to the PTBC—please include your name and license number.

Who is the Physical Therapy Board of California?

The Physical Therapy Board of California (PTBC) is a government agency within the Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. The PTBC provides three principal types of consumer services: verifies education and background prior to licensure, provides information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

Board Meetings

Board meetings are mandated to three board meetings a year. Typically, the PTBC conducts four meetings a year in the areas of Northern and Southern California. Board meetings are usually two days long and the public is highly encouraged to attend.

Benefits of Hosting a Board Meeting

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voice heard on topics being discussed.
- Students and applicants can attend in between classes and learn how the PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

To advance and protect the interests of the people of California by the effective administration of the Physical Therapy Practice Act.

XHEXXER OF A PHYSICAL THERAPY STUDENT DURING THE PANDEMIC BY MELANIE FRANCISCO

Like many in my cohort and those before us, I was first exposed to physical therapy (P.T.) through sports. With a 12-year gymnastics career—eight of them involving training around 25 hours per week as part of a competitive traveling team—there was hardly a day when one of us wasn't injured. I've witnessed gymnasts dislocate their elbows, land on their necks, and tear ACLs. I've even accidentally flipped onto the balance beam support resulting in a traumatic brain injury and amnesia. Through my friends' and my personal experiences, the world of physical rehab became very familiar to me. Seeking a career that combines my love for movement with wanting the best outcomes for those with injuries naturally led me to physical therapy. I graduated from California State University, Sacramento, with a bachelor's degree in kinesiology—exercise science, with a specialization in clinical exercise and rehabilitation. While volunteering at a hospital and clinics during undergrad and working as an aide, I learned about the wide scope of P.T. practice and education. Today, I am a second-year student physical therapist at the University of the Pacific getting ready to embark on my clinical education rotations.

One thing that sets current second- and thirdyear cohorts apart from previous classes is the unprecedented experience of the abrupt and impromptu transition from in-person to distance learning during our rigorous doctorate programs. The global pandemic has affected all facets of life for many people, and we have not been immune to these changes. As a student in an accelerated doctorate of physical therapy (DPT) program, I have come to learn that face-to-face, hands-on learning is paramount to prepare ourselves for our quicklyapproaching careers. Though some topics such as pathophysiology, research, and documentation may not necessarily be taught much differently as an online lecture course, this is not the case for learning practical skills like transfers, manual

techniques, or therapeutic exercises. Simply talking about how to do a maneuver to roll a person is not the same as actually handling a weighted, human form. And while I am thankful for platforms like Zoom, it just doesn't cut it.

Using an online survey, I was able to reach out and get feedback from nearly 60 students across three California DPT programs regarding their opinions on distance learning as compared to in-person classes. I included categories involving physical, mental, and emotional pros and cons of distance learning to reflect different aspects of our new student lives.

First, the cons. Nearly all students (96.6%) consider having less hands-on time to be a negative of distance learning. A high majority of respondents (approximately 75% or more) consider having less face-to-face time with their peers and faculty and being easily distracted as cons. At least 60% responded that they learn better in-person, can't concentrate at home, don't have someone to study or practice with, and experience lethargic or other negative feelings. Professors' technical difficulties during class and an increased amount of work given were also cons experienced by this large majority. Notable cons of the responding students also include being less active, not relating to classmates, no access to resources such as the library, unchanged or increased expectations from professors though the education is not the same, feelings of unpreparedness for exams and career, and declining confidence and mental health.

However, the switch to distance learning has some pros. Around 75% or more participants found it positive that they don't have to commute as often, are saving money on gas, and have a decreased risk of exposure to COVID-19. At least 50% of students can spend more time with those they live with and pets, and save some time associated with going to class (e.g., meal prep, getting dressed/ready, and/ or packing). Some students (approximately 45%)

have been getting to sleep in more and get more things done around the house. Notable pros are the flexibility of class and more time for self-care.

The "new normal" has given rise to a different P.T. school experience than what we signed up for. The backdrop of the pandemic plus political and social unrest locally and internationally may also be exacerbating effects felt by students, especially since we cannot unplug from online communications. Yet through these contemporary crises, P.T. students across California continue to endure and invest in their education and careers. My program has been extremely lucky to have professors and faculty who have bent over backwards to get us essential lab time, and we have valued every moment of these hours. To my fellow students who are struggling, I am struggling with you. We joined this noble profession with passion to provide knowledge and care to our patients. It is important to not lose sight of that. I hope that we physical therapists will continue to advocate for and be gentle with ourselves and each other, for our sake and our patients, and to continue our growth as a collective.

PROGRESS NOTES SPRING 2021

In March 2020. COVID-19 lockdown orders were issued in California and across the U.S. The Physical Therapy Board of California's (PTBC) Application Services Program faced the unprecedented challenge of continuing to serve the people of California by ensuring physical therapist (P.T.) and physical therapist assistant (PTA) applicants met the qualifications for licensure and were licensed in as reasonable a time frame as the situation allowed. The pandemic caused applicant resources to be unavailable, limited, or rescheduled. As state employees and designated essential workers, PTBC staff are charged with keeping the PTBC operational. A pandemic shutdown cannot equate to a work stoppage.


The difficulties guiding P.T. and PTA applicants through the application process to qualify for licensure were several: delayed education program completion, limited access to testing, and unavailability of fingerprint vendors. Many students' clinical rotations that are required for program completion and graduation were delayed. Clinical sites were closing completely, or if they remained open, only retained the necessary providers. This generated concern for both students and school programs who then contacted the PTBC for guidance.

The Federation of State Boards of Physical Therapy (FSBPT), the organization that administers both exams required for P.T. and PTA licensure, cancelled all April exams without a clear plan to reschedule due to necessary disinfection, Personal Protective Equipment (PPE), and physical distancing at the testing centers. When FSBPT began rescheduling exams in May, applicants' ability to schedule depended upon the stay-at-home orders of the state in which the testing center was located. Moreover, seating was severely limited in all testing centers to ensure social distancing standards were followed. Most California Live Scan locations, which in-state applicants access to submit their fingerprints for the required background check, closed until further notice. Also, out-of-state police departments that are the go-to provider of fingerprinting services for endorsement applicants would not allow members of the general public in their offices. Therefore, many applications were deficient for lack of fingerprint results; however, this did not prohibit the applicants from scheduling their exams.

In addition to supporting its stakeholders, PTBC along with most other state government agencies were almost instantaneously transitioned to work at home with limited access to the office for the purpose of health and safety—limiting exposure and slowing the spread of COVID-19. This required all staff to adjust to new technology, working environments, and how they interacted and communicated within the organization and with stakeholders. Staff not only needed to assist stakeholders in navigating the effects of the pandemic but were doing so themselves as well.

While the pandemic initiated a statewide lockdown, PTBC Application Services Unit staff remained available to respond to inquiries about closed clinical sites and delayed completion of clinical rotations and education programs. In addition, staff offered resources for assistance since the PTBC does not directly approve or accredit education programs. When students were able to complete their programs, the PTBC implemented electronic education verification to increase application processing efficiency and issuance of License Applicant status: a status that permits applicants for licensure to work under specific supervision pending the results of their exams. The PTBC closely monitored the progress on examination opportunities following the cancellation of examinations. Staff worked to prepare applicants for examination and licensure while the examinations were cancelled so applicants would be ready and free of any delays in scheduling their examinations when the examinations resumed. When applicants successfully completed the required examinations and the applications were complete, staff made every effort to issue licenses as quickly as possible to facilitate the ability for new licensees to begin working to serve California consumers and, for many, to address student loans. This same approach was taken for applicants with application delays due to closed fingerprinting sites, which staff accommodated by working to eliminate any further licensure delays.

Applications Services staff consistently demonstrated their flexibility and commitment to PTBC's stakeholders throughout the past year, which is reflected in the PTBC's Application Services statistics. From March through December 2020, P.T. and PTA applications received and processed declined less than 10% from the prior year, a year without the difficulties associated with the pandemic. Similarly, for the same timeframe, P.T. and PTA licenses issued also declined less than 10% from the prior year. Although these declines were expected during this time period due to limited applicant resources, Application Services Unit staff worked to assist applicants through the application process and eliminate undue burden on the applicants, who had already endured other difficulties. The PTBC looks forward to continuing its commitment to California consumers and license applicants by ensuring applicants meet the minimum qualifications of licensure efficiently with professionalism, proficiency, and empathy.


School Presentations During the Pandemic

Q. What drew you to wanting to serve on the Physical Therapy Board of California?



SUBSTANCE ABUSE REHABILITATION HOTLINE



Physical therapists (P.T.s) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10 percent of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including P.T.s and PTAs, may be particularly susceptible to substance abuse problems due to the stresses of working in a health care environment and due to an increased opportunity to obtain controlled substances.

Many P.T.s and PTAs who experience problems with chemical dependency can find the help and support they need to stay clean and sober without involvement from the Physical Therapy Board of California (PTBC).

Unfortunately, most people suffering from chemical dependency deny the problem. Many times, they are the last to recognize and admit that they need help. If chemical dependency problems are left untreated, they may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted.

In these cases, it becomes imperative that individuals who detect a chemical dependency health problem in a P.T. or PTA take action. Without intervention, diseases have predictable courses and outcomes. The PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

PTBC is eliminating the pocket license

The Physical Therapy Board of California (PTBC) is making license verification more effective and efficient for consumers and licensees. Effective July 2020, the PTBC will no longer issue pocket licenses upon initial licensure or renewal. Pocket licenses may not reflect a licensee's current status as it may change within the two-year license period, and they do not display enforcement action taken against a license, if any. Current license status and enforcement action information is available on Department of Consumer Affairs (DCA) License Search, an online license verification system. Consumers, employers, or any interested party can access license information online 24 hours a day, seven days a week. You can access the DCA License Search system on the home page of the PTBC website at www.ptbc.ca.gov.






