PRESIDENT'S MESSAGE



The Work of PTBC in 2022

Despite the fluctuations of COVID-19 cases and rules, it has been a busy time for the Physical Therapy Board of California (PTBC) and all stakeholders. Most physical therapist (P.T.) and physical therapist assistant (PTA) programs have returned to in-person learning. Many national conferences are now back in person as well. PTBC even managed to have an in-person Board meeting with all necessary safety measures in place in December. The essential work of P.T.s and PTAs is keeping clinic doors open, which is good news for the consumers of California who are reaping the benefits of necessary physical therapy services.

This year promises to be noteworthy for PTBC. First on deck, March 10, 2022, was our sunset review. This process occurs about every five years. Board members and staff spent a good part of the last quarter in 2021 preparing our Sunset Review Report for the Joint Sunset Review Oversight Hearings. The sunset review process provides an opportunity for the Department of Consumer Affairs (DCA), the Legislature, the boards, and interested parties and stakeholders to discuss the performance of the boards and make recommendations for improvements. We look forward to reporting the results of our sunset review in subsequent communications.

The next large project will be preparing to update the strategic plan for PTBC. We will reassess and report our progress toward past objectives and then turn to you, our stakeholders, to participate in discussions to help us create a bridge from our vision to our next set of objectives for the coming four years. Keep an eye and ear out this year for more information on how you can be a part of this important process.

An anticipated highlight at the end of this year is the Federation of State Boards of Physical Therapy Annual Meeting in Southern California. I am committed to learning ways to improve the work of the Board and ensure all Californians have access to safe, high-quality physical therapy services. This annual conference will inform the Board about new processes and additional tools as Board members and staff continue to look for ways to ensure consumer protection.

Along with multiple exciting events this year, the regular business of the Board continues. In response to the pandemic, all units continue to search for ways to work smarter: Enforcement cases are still being processed; licensees are still being issued and renewed; and Board staff still carries on with P.T. and PTA program presentations. So far, PTBC staff has presented to almost every school program in California.

Aside from regular Board business, Board members continue to meet quarterly. Please see our website and join us for our regularly scheduled meetings, as well as special sessions sprinkled throughout the year. PTBC is mandated to meet three times a year, but PTBC met six times in 2021. We look forward to returning to in-person meetings this year and travelling throughout the state again. This gives all stakeholders the opportunity to attend a meeting in person. Whether in person or virtual, you are always an invited and welcomed partner in the work of PTBC.

Do We Have Your Email Address?

Licensees are required to provide the Physical Therapy Board of California (PTBC) with an email address if the licensee has one. Email is an efficient conduit for sharing information between PTBC and its applicants and licensees. PTBC will be able to communicate regarding the status of applications, renewals, and requests for various PTBC services; provide law and regulation updates; and disseminate important PTBC news directly to each applicant and licensee—from PTBC to your door (or email inbox). It doesn't get much easier! PTBC hopes this accelerated delivery and exchange of information will decrease processing times in all aspects of 's programs and facilitate licensees keeping apprised of laws and regulations and PTBC activities. Moreover, with the transition to the BreEZe system, email will be the standard method of communication. You can submit/update your email address using BreEZe or submit your address change

with BreEZe. You may also submit your email address in writing to PTBC—please include your name and license number.

Who is the Physical Therapy Board of California?

The Physical Therapy Board of California (PTBC) is a government agency within the Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. PTBC provides three principal types of consumer services: verifies education and background prior to licensure, provides information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

Board Meetings

Board meetings are mandated to three board meetings a year. Typically, PTBC conducts four meetings a year in the areas of Northern and Southern California. Board meetings are usually two days long and the public is highly encouraged to attend.

Benefits of Hosting a Board Meeting

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voice heard on topics being discussed.
- Students and applicants can attend in between classes and learn how PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

MILITARY APPLICANT? WE'RE READY TO HELP!



The Physical Therapy Board of California (PTBC) is committed to assisting members of the military and their families through expedited licensure and license renewal accommodations, and I am the one who makes this happen. My name is Paul Row, and I am the

military and endorsement liaison for the Applications and Licensing Unit. I process and evaluate military and endorsement initial license applications and assist licensees in the military with renewal accommodations.

A little about me: I served in the Navy for five years as an airframe's technician and a shift supervisor. I retired from AT&T, my last position, as an internet installation and repair technician. I have been with the state since 2016. My first position was in the Public Information Center for the Board of Registered Nursing (BRN). My tasks included answering the phones, renewal processing, working the front counter, and then working with the administrative department. In 2017, I was hired in the licensing and applications department at BRN. I learned and processed all varieties of endorsement and exam applications. After four years I felt that I had reached my potential and was ready for a new challenge. Last year, I started at PTBC. I have enjoyed the new challenges that this position has brought. I have learned new skills and have expanded my application and evaluation knowledge. I am excited for this opportunity to respond to common questions regarding military expedite of initial licensure applications as well as share some tips to hopefully make navigating the process easier!

1. What does an applicant need to submit to qualify for military expedite of their application?

In addition to the information and documentation required for a license, you need to submit the following:

- If you are an applicant who has been honorably discharged, a copy of the DD-214 is required.
- If you are an applicant currently serving in the military, proof of active duty is required.
- For military spouse applicants, you need to supply evidence you are married to, or in a domestic partnership or other legal union with, an active-duty member and supply orders that they are being assigned to a duty station in California.

2. Do military applicants have to fulfill all application requirements, or are some requirements waived?

While the application process for members of the military and family of members of military is expedited, all requirements for licensure must be fulfilled; all qualifications for licensure must be met. No license application requirements are waived. This is to ensure all licensees, regardless of license qualification method, meet the same minimum safety and competency standards to care for California physical therapy consumers.

3. How long will it take a military applicant to get a California license?

A military application can be processed within one week or up to one year; much of it depends on you:

• If you take the California Law Examination (more on this later) before you apply.

- If you submit all required documents at the time of submitting your application.
- Fingerprinting.
- Criminal history may delay the process.

4. Where can I find the application instructions?

It's so easy. Instructions to apply for licensure are available on PTBC's website under the Applicants tab—<u>How to Apply</u>. The website also has a designated page for <u>Military Resources</u> under the Applicants tab.

5. Do I need to take the California Law Examination (Cal-Law)?

Yes, you must take the Cal-Law exam, and it is available to take in any state at a Prometric testing center. You may take the exam prior to applying to PTBC for licensure. If you take the Cal-Law prior to applying to PTBC, you must submit your application within one year of your Cal-Law test date. If you do not apply within one year of your Cal-Law test date, you will be required to take the Cal-Law again. <u>Study</u> <u>resources for the Cal-Law exam can be found</u> <u>on the website under the Publications tab</u>.

6. Does PTBC have a temporary license until I get my regular, renewable license?

Yes, PTBC refers to this temporary licensure as Physical Therapist or Physical Therapist Assistant License Applicant Status (PTLA/PTALA). Endorsement applicants may be granted PTLA/ PTALA status at first review. For new graduates the P1E form sent from the applicant's physical therapy program is required for granting PTLA/ PTALA status. Supervision requirements are set forth in Business and Professions Code (BPC) section 2639:

A physical therapist license applicant whose application for licensure has been filed and reviewed by the board may perform as a physical therapist if he or she is under the direct and immediate supervision of a physical therapist licensed by the board. "Direct and immediate supervision" means a supervisor shall at all times be responsible for and provide adequate supervision of the work performed by the physical therapist license applicant and shall be in close proximity to the location where the physical therapist license applicant is rendering physical therapy treatment. The physical therapist license applicant shall document each treatment in the patient record, along with his or her signature. A supervising physical therapist shall countersign with his or her first initial and last name in the patient's record on the same day as patient related tasks were provided by the physical therapist license applicant.

While PTLA/PTALA is available, PTBC's goal is to issue you a regular renewable license so timely you do not need it.

7. Do I need to submit a license verification and a Certificate of Completion (P1E)/physical therapy education program transcripts?


For the most part, PTBC is able to verify licenses from other jurisdictions online. If PTBC is unable to obtain the information it needs to verify a license held in another jurisdiction, PTBC will notify you; you may need to submit a license verification from that jurisdiction.

A Certificate of Completion (P1E) confirms completion of a Commission on Accreditation in Physical Therapy Education (CAPTE)accredited physical therapy program, and this must be verified pursuant to Business and Professions Code section 2650.

8. How should I submit my fingerprints?

All applicants must complete Live Scan (digital) fingerprinting for California. Live Scan fingerprinting must be done in California. If you are not in California at the time of application, you may fingerprint at any point during the application process for the life of your application—one year. The Live Scan form will be completed by the Live Scan operator processing your fingerprints. In addition, you must also sign the Live Scan form confirmation you received the attached information privacy notices attached to the Live Scan form. Once completed, the form must be submitted to PTBC by attaching it to the BreEZe online application.

LAWS AND REGULATIONS UPDATE



LAWS

• Assembly Bill 361 Open Meetings: State and Local Agencies: Teleconferences (Robert Rivas) Chapter 165, Statutes of 2021, Effective January 1, 2022.

This bill allows, until January 1, 2024, local agencies to use teleconferencing without complying with specified Ralph. M Brown Act restrictions in certain state emergencies, and provides similar authorizations, until January 31, 2022, for state agencies subject to the Bagley-Keene Open Meetings Act and legislative bodies subject to the Gloria Romero Open Meetings Act of 2000.



• AB 1273 Interagency Advisory Committee on Apprenticeship: The Director of Consumer Affairs and the State Public Health Officer: Earn and Learn Training (Rodriguez) Chapter 477, Statutes of 2021, Effective January 1, 2022.

This law expands membership of the Interagency Advisory Committee on Apprenticeship to include the state public health officer and the director of the Department of Consumer Affairs; and expands the use of the "earn and learn" training model by preventing these two government entities from prohibiting its use for personnel training or accreditation of programs and requiring them to use licensing or certification standards that authorize it.

• Senate Bill 607 Business and Professions (Min) Chapter 367, Statutes of 2021, Effective January 1, 2022.

This law is a Senate Business, Professions and Economic Development Committee omnibus bill and makes statutory updates, technical corrections, and noncontroversial changes to various provisions of law relating to boards and bureaus under the Department of Consumer Affairs.

LAWS AND REGULATIONS UPDATE



REGULATIONS

The following additions or modifications are to Title 16, Division 13.2, of the California Code of Regulations.

• Disciplinary Guidelines, Effective April 1, 2022

The amendment to section 1399.15 of Title 16 of the California Code of Regulations incorporates by reference PTBC's Disciplinary Guidelines (6th Edition—Revised September 2020).

PTBC uses the Disciplinary Guidelines for issuing citations and imposing discipline. PTBC made several changes to the 6th Edition Disciplinary Guidelines to reflect regulatory changes already adopted. Additionally, a requirement was added to the Disciplinary Guidelines to inform probationers that their license will not be renewed if they do not pay probation monitoring costs. An option to reduce these cost recovery fees was removed and instead PTBC is offering the possibility of a payment plan requiring payment 180 days prior to completing probation. Substance abuse rehabilitation program fees were removed and PTBC also added an additional specific condition of probation, entitled "Notification of Probation Status to Assistive Personnel," and made several nonsubstantive changes to the Disciplinary Guidelines.

 Substantial Relationship Criteria, Rehabilitation Criteria for Denial and Reinstatement of Licensure and Rehabilitation Criteria for Suspension and Revocations, Effective November 30, 2021.

The amendments to sections 1399.20; 1399.21; and 1399.22 of Title 16 of the California Code of Regulations established criteria for PTBC to consider in determining whether a crime, professional misconduct, or other act committed by an applicant or licensee is substantially related to the qualifications, functions, or duties of the licensed profession when deciding whether to deny, suspend, or revoke a license. The action also establishes criteria for PTBC to consider in evaluating whether such applicant or licensee has been rehabilitated since a criminal conviction or other act leading to denial, suspension, or revocation of a license or when considering a petition for reinstatement of a suspended or revoked license. This action implements amendments to the Business and Professions Code made by Assembly Bill 2138 (Stats. 2018, Ch. 995).

MEET CAROLE PHELPS, ENFORCEMENT ANALYST

- **1. How long have you been in your position?** I have been an enforcement analyst since 2009.
- 2. What made you decide to choose this career? PTBC provides a very stable and enjoyable work environment, and my co-workers are some of the best people out there. The job of enforcement analyst is appealing to me because every case is different and presents its own unique challenges, so I am constantly learning and sharpening my skills.

3. What are the most common complaints you receive?

Most of the complaints I handle involve allegations of improper physical therapy treatments, inaccurate billing, or unprofessional conduct as it relates to the practice of physical therapy.

4. What is your role in working a case?

I am responsible for gathering evidence and information regarding the complaint allegations from all involved parties. I conduct investigations from my desk here in Sacramento, so if a facility site visit or interviews are needed, I forward the case to the Division of Investigation, which has field offices throughout California. Once an investigation is complete, I analyze all available information and make a recommendation to the executive officer, who determines whether disciplinary action will be sought. If disciplinary action is requested, I work with the Attorney General's Office to go through the process of pursuing administrative disciplinary action against a licensee.

5. How are cases opened?

When a complaint is received, a new case is initiated in BreEZe, our case management system. The intake analyst enters all information received from the complainant, and the case is assigned to an enforcement analyst based on the type of complaint and each analyst's caseload.

6. How are cases investigated?

We must determine if there is evidence to support the allegations made in the complaint. This can be accomplished in a number of ways, but usually involves obtaining a written response and/or documentation from the subject of the complaint, obtaining and reviewing patient records, conducting interviews of involved parties, and/ or having a physical therapist expert consultant perform a site visit to review patient records at the subject facility.

7. Who determines what disciplinary action is taken?

As the enforcement analyst assigned to a case, I review and analyze the information and evidence collected during the investigation, and make recommendations to the executive officer, who has authority to determine whether disciplinary action will be sought in any given case. We can also receive advice about the strength (or weakness) of a case from the Attorney General's Office. But, ultimately, the Board members review all disciplinary cases to determine whether and what disciplinary action is taken.

8. What is your favorite part of the job?

I absolutely could not ask for better co-workers. Everyone is so supportive of each other. Oftentimes tough questions or complicated cases require more than one set of eyes, and people here are 100% willing to jump in and help.

9. What is your least favorite part of your job? It can be difficult to have to review the details of some of the more egregious complaint cases, where patients suffered serious harm.

10. What would you like consumers to know about filing a complaint?


When you submit your complaint, please provide multiple ways for PTBC to contact you, and provide details and as much back-up information as possible. PTBC is required to show proof of violation to take any disciplinary action, so the more information the consumer provides, the easier it is to investigate the matter, obtain sufficient evidence to determine if a violation can be substantiated, and decide if disciplinary action is warranted.

11. What would your advice be to a licensee who had a complaint filed against them?

Be diligent in responding to PTBC's requests for information. And please don't be afraid to call us. Each case is assigned to an individual analyst, who should be able to help answer your questions about your specific complaint. One of the Board's goals is to ensure compliance with the laws and regulations—we are not out to "get" the licensee, and a majority of complaint cases are resolved without the need to impose discipline.



SUBSTANCE ABUSE REHABILITATION HOTLINE



Physical therapists (P.T.s) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10% of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including P.T.s and PTAs, may be particularly susceptible to substance abuse problems due to the stresses of working in a health care environment and an increased opportunity to obtain controlled substances.

Many P.T.s and PTAs who experience problems with chemical dependency can find the help and support they need to stay sober without involvement from the Physical Therapy Board of California (PTBC).

Unfortunately, most people suffering from chemical dependency deny the problem. Many times, they are the last to recognize and admit they need help. If chemical dependency problems are left untreated, they

may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted.

In these cases, it becomes imperative that individuals who detect a chemical dependency health problem in a P.T. or PTA take action. Without intervention, diseases have predictable courses and outcomes. PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

PTBC HAS ELIMINATED THE POCKET LICENSE

The Physical Therapy Board of California (PTBC) has made license verification more effective and efficient for consumers and licensees. Effective July 2020, PTBC no longer issues pocket licenses upon initial licensure or renewal. Pocket licenses may not reflect a licensee's current status as it may change within the two-year license period, and they do not display enforcement action taken against a license, if any. Current license status and enforcement action information is available on Department of Consumer Affairs (DCA) License Search, an online license verification system. Consumers, employers, or any interested party can access license information online 24/7. You can access the DCA License Search system on the home page of the PTBC website at www.ptbc.ca.gov.






