#### Who is the Physical Therapy Board of California?

The Physical Therapy Board of California (PTBC) is a government agency within the Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. The PTBC provides three principal types of consumer services: verifies education and background prior to licensure, provides information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

#### **Board Meetings**

Board meetings are mandated to three board meetings a year. Typically, the PTBC conducts four meetings a year in the areas of Northern and Southern California. Board meetings are usually two days long and the public is highly encouraged to attend.

#### Benefits of Hosting a Board Meeting

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voice heard on topics being discussed.
- Students and applicants can attend in between classes and learn how the PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

# MY JOURNEY TO BECOMING A LICENSED PHYSICAL THERAPIST BY JEREMY YEE, P.T., DPT

The journey to becoming a licensed physical therapist was challenging, yet highly rewarding. Following years of physical therapy school, we still must pass the Board exams: National Physical Therapy Exam (NPTE) and California Law Exam (CAL-Law). I graduated from University of California, San Francisco/San Francisco State University (UCSF/SFSU) Doctor of Physical Therapy (DPT) Program in June 2019. As I approached graduation, I was slightly overwhelmed and felt uncertain about how to start applying, as well as how to prepare for the Board exams. By sharing my personal experiences, I hope that you will be better prepared for your journey to becoming a licensed physical therapist.

There are two applications required to obtain physical therapy licensure. In total, I spent over \$1,100 on these applications. The first application is to the Federation of State Boards of Physical Therapy (FSBPT), which allows you to register for the NPTE and CAL-Law exams. Three months prior to graduation, my DPT program sent certificates of completion (P1E) directly to the Physical Therapy Board of California (PTBC). Afterwards, I created an online account with the FSBPT and registered for the NPTE and CAL-Law exams. Shortly after registering for each exam, I received an email from the FSBPT with authorization to test, which allowed me to schedule each exam at Prometric's testing centers. I scheduled both exams at the Fair Oaks location in Sacramento: NPTE on July 25 and CAL-Law on August 8.

The second application is through BreEZe to the PTBC, which verifies and issues licensure. There are multiple components to the BreEZe application, including a Live Scan service for fingerprint submission, which I completed at a local UPS Store.

My preparation for the NPTE began during my didactic training at UCSF/SFSU. The program required students to pass three qualifying exams in acute care, orthopedics, and neuromuscular. Each exam included clinical scenarios in a similar format to the NPTE. In addition to studying for the qualifying exams and reviewing didactic material, I purchased the Scorebuilders study guide, which included three practice exams, each consisting of four sections and a total of 200 questions. I also purchased the Practice Exam and Assessment Tool (PEAT) through FSBPT, which included two additional practice exams, each consisting of five sections and a total of 250 questions, similar to the actual NPTE. Additionally, I used two smartphone applications: NPTE-PT Pocket Prep and PT365 via Scorebuilders. Each application provided daily practice questions and short quizzes.

In conjunction with the Scorebuilders study guide, I created a six-week study schedule based on the primary systems that the NPTE focuses on. For example, I spent my first week primarily on musculoskeletal, second week on neuromuscular, third week on cardiopulmonary, and so on. At the end of each week, I took a practice exam. I spent the following couple days reviewing each exam, determined my areas of strengths and weaknesses, and adjusted my study plan accordingly. To prevent burnout and mental fatigue, I incorporated multiple study breaks throughout each day and at least one day off from studying per week.

On the day of the NPTE, I arrived early to the testing center and the check-in process was efficient. The NPTE consisted of 250 questions, five sections with 50 questions each, five hours total with one scheduled

20-minute break after the second section. I also took an optional break after the fourth section. By the end of the exam, I nearly ran out of time and did not feel very confident about my performance. Reflecting on this experience, I likely would have benefitted from an additional one or two weeks of studying and additional practice exams.

Meanwhile, the CAL-Law consisted of 50 questions for a total of 60 minutes. To prepare for this exam, I spent about one week primarily studying the reference guide provided on the PTBC website: California Laws and Regulations Related to the Practice of Physical Therapy (available at <a href="https://www.ptbc.ca.gov">www.ptbc.ca.gov</a> under the "Applicants" tab). In comparison to the NPTE, the CAL-Law was less mentally fatiguing, and I completed the exam with plenty of time to spare.

Within one week following each exam, I received the results on my FSBPT account: pass! And within one week of passing the CAL-Law, my P.T. License verification was posted on my BreEZe account. All of my diligent studying and hard work paid off, and I officially became a licensed physical therapist in California!

## BUDGET HIGHLIGHTS BY KENNETH MEISS

The Physical Therapy Board of California (PTBC) licenses and regulates physical therapists, physical therapist assistants, and the practice of electroneuromyography and kinesiological electromyography performed by physical therapists.


The PTBC Fund is constituted as a Special Fund Revenue within the State Treasury. The PTBC Fund is comprised of all monies collected from applicants and licensees through licensing, renewal, endorsements (license verifications) and administrative actions, i.e., citations, cost recovery, and probation monitoring. The PTBC's funds are reserved to pay for all salaries and all other operating expenses and equipment to sustain program operations. The PTBC budget appropriation is developed annually and is subject to legislative approval and may be increased through the Budget Change Proposal (BCP) process. The BCP process allows the PTBC to justify the need to increase its annual budget appropriation necessarily to support program operations effectively and efficiently.






## WHAT HAPPENS AFTER A COMPLAINT IS FILED? BY CAROLE PHELPS

The Physical Therapy Board of California (PTBC) receives and investigates a variety of complaints against physical therapy care providers. Complaints can be submitted about services provided, sexual misconduct, billing issues, convictions, unlicensed practice, malpractice, personal conduct, or any concerns a consumer may have. Complaints are filed by patients, caregivers, insurance providers, other licensees, and other members of the public.

The complaint investigation process can be quite lengthy, involving multiple parties, including the Consumer Protection Services (CPS) analyst, sworn investigators, physical therapist expert consultants, and attorneys. Complaints are reviewed by the Board's CPS Program analyst, whose first step is to determine if the PTBC has jurisdiction over the issues addressed in the complaint. If the PTBC has jurisdiction, the complaint is assigned to a CPS analyst for investigation and an acknowledgement letter is sent to the complainant. Complaints are considered confidential, so the PTBC will not notify or provide a copy of the complainant (until required to do so by law).

The CPS analyst reviews each complaint and conducts an investigation, gathering evidence and information to determine if the alleged violation(s) have merit and can be proven. Complaint allegations can vary widely, so no two investigations follow the exact same steps. The analyst may request additional information in writing from the complainant, the licensee, and/or directly from the involved care facility. Sometimes, complaints are received anonymously, and in those cases, the PTBC is not able to reach out to the complainant for additional information. Although anonymous complainant cases are difficult to pursue, the PTBC will attempt to obtain information to determine if there is merit to the complaint and/or jurisdiction.

If the complaint allegations include concerns regarding physical therapy care received, patient treatment records are obtained for review. The PTBC cannot obtain a copy of a patient's medical records without the patient's written permission. Therefore, an Authorization for Release of Patient Health Information form must be obtained from the patient. Once records are obtained, they are reviewed by a physical therapist expert consultant to determine if there is evidence of violations including negligence, incompetence, potential billing fraud, improper supervision of assistive personnel, and any other potential concerns regarding the care rendered to the patient(s). The expert consultant provides their findings to the PTBC in a written report.

In some cases, an onsite visit to the care facility is required in order to conduct in-person interviews of involved parties

(the complainant, the licensee, and any witnesses) and/or to review medical records. If in-person interviews or a visit to the care facility are needed, the analyst will forward the complaint to the Department of Consumer Affairs Division of Investigation (DOI), which conducts all field investigations for the PTBC. At the conclusion of the field investigation, the DOI investigator provides a written report to the PTBC containing their findings and any evidence that was obtained.

Once all requested information and reports are received, the analyst reviews the evidence with the CPS manager and/or the PTBC's executive officer to determine if a violation of the Physical Therapy Practice Act occurred and to determine what level of action is appropriate, if any.

If there is sufficient evidence of serious violation(s) to warrant disciplinary action against the licensee(s), the consumer complaint and all relevant evidence are referred to the Department of Justice's Office of the Attorney General to initiate a legal proceeding to revoke, suspend, limit, or condition the license, which is called an accusation. (Gov. Code, § 11503.) The Office of the Attorney General acts as the PTBC's legal counsel for all disciplinary proceedings. The case is assigned to a Deputy Attorney General (DAG) and the analyst works closely with the DAG on the disciplinary process. The PTBC must prove the allegations by clear and convincing evidence to a reasonably certainty in order to take disciplinary action against a licensee.

If less egregious violation(s) are found that don't warrant disciplinary action, the PTBC may issue an administrative citation and fine to the licensee, send a closing educational letter to the licensee referencing current laws related to any areas of concern, or close the case without further action. If no violations are found, the PTBC closes its case with no action. These types of case closures are not considered disciplinary action.

When the investigation and any resulting PTBC action are complete, the analyst will notify the complainant and the licensee of the outcome in writing. All investigative files are retained in the PTBC's files as prescribed by law and may be a source of consideration if any subsequent complaint is received by the PTBC.

## CONTINUING COMPETENCY BY SARAH CONLEY

Building on the continuing competency pathways development discussion in the Spring 2020 Progress Notes article, in this issue we will delve into the details of continuing competency requirements and address some common questions.

The traditional continuing competency pathway includes all education courses approved by an agency recognized by the Physical Therapy Board of California (PTBC) and college coursework from an educational institution accredited by the U.S. Department of Education or by the regulatory authority of any state. The PTBC has recognized over 120 approval agencies to approve providers and courses, and these recognized approval agencies have approved over 14,000 continuing competency courses. Approved courses are deemed compliant with California continuing competency provider and course requirements and are accepted by the PTBC to fulfill the biennial continuing competency renewal obligation. So, how do licensees find these courses? The program structure is that the PTBC recognizes approval agencies, and recognized approval agencies approve providers and courses. However, the PTBC does not provide a list of approved providers and courses. The

PTBC does list all recognized approval agencies on its website and identifies which agencies: 1) approve providers other than their own, 2) approve individual licensees, 3) offer retroactive approval, 4) offer basic life support for health care professionals, and 5) offer laws and ethics. The PTBC encourages licensees to take time to explore the approved continuing competency opportunities through the various recognized approval agencies. With recognized approval agency courses and courses available through accredited educational institutions, there is a wide variety of subject matters and delivery methods for the traditional continuing competency pathway.

While solely using the traditional pathway is acceptable, the PTBC recognized there are other professional development mechanisms, found value in the activities, and saw that they offered greater flexibility to licensees. The Alternate continuing competency pathway provides licensees the opportunity to apply non-traditional activities to the biennial continuing competency renewal obligation. Here is the list of approved Alternate pathway activities and the hours that may be earned for completing them:

The PTBC is often asked why it does not accept courses accepted by other regulatory entities within California and from other states. It is not that the PTBC does not accept the courses; it is that the PTBC must first ensure these courses meet PTBC standards. This vetting process is through the recognized approval agencies. So, while the PTBC does not accept continuing competency activities not within the traditional and alternate pathways, there is still opportunity for other, non-approved courses to be approved by a PTBC recognized approval agency before it is offered or approved retroactively. However, course approval is at the discretion of the recognized approval agency. Although they have the authority, they are not required to approve any course.

While there are different continuing competency pathways, there are content standards that apply across all continuing competency activities. Hours, whether traditional or alternate, must be obtained in subjects related to either the professional practice of physical therapy or patient/client management. The professional practice of physical therapy includes, but is not limited to, professional accountability, professional behavior, and professional development. Patient/client management includes, but is not limited to, examination, evaluation, and diagnosis and prognosis, implementation, and discharge. Moreover, aside from the pathways and content standards, the PTBC specifically requires two hours in ethics, laws and regulations, or some combination thereof; and four hours in life support for health care professionals. The life support training should be comparable to, or more

advanced than, the American Heart Association's Basic Life Support Health Care Provider Course.

We just discussed the number of hours required for ethics, laws, and regulations as well as life support training, but how many continuing competency hours are required in total? For most licensees, the biennial continuing competency renewal obligation is 30 hours. The same number of hours is required for both physical therapist and physical therapist assistant licensees. The activities must be completed in the two-year period prior to the current license expiration date. If it is a licensee's first time renewing, only 15 hours of continuing competency is required to be completed between the first license issue date and the license expiration date. Licensees should receive a completion confirmation, often a certificate of completion, for each activity. This documentation is to be maintained by the licensee, not the PTBC. Licensees are not required to submit proof of completed continuing competency activities with renewal; if documents are submitted, the PTBC will return them to the licensee. Licensees must maintain their activity completion records for five years following the activity end date. A licensee is expected to produce the records upon the PTBC's request. Since licensees are not required to provide evidence of compliance upon renewal, they are required to certify under penalty of perjury that they are in compliance with the continuing competency renewal obligation.

## TOP PTBC VIOLATIONS

The Physical Therapy Board of California (PTBC) is a California state government agency that licenses physical therapist and physical therapist assistants and regulates the practice of physical therapy. The mission of the PTBC is to advance and protect the interests of the people of California by the effective administration of the Physical Therapy Practice Act. To meet its mandate, the PTBC does this by investigating complaints against physical therapy professionals and the unlicensed practice of physical therapy. When warranted, administrative citations

or disciplinary action is initiated. Data taken as of July 2020 shows that the PTBC has a total of 33,488 licensees. Of these licensees, 489 complaints were received by the PTBC that year. The most common complaints received by the PTBC were:

- 1. Criminal convictions—abuse and/or possession of drugs or alcohol
- 2. Documentation and/or supervision of assistive personnel
- 3. Negligence/incompetence

## SUBSTANCE ABUSE REHABILITATION HOTLINE

Physical therapists (P.T.s) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10% of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including P.T.s and PTAs, may be particularly susceptible to substance abuse problems due to the stresses of working in a health care environment and due to an increased opportunity to obtain controlled substances.

Many P.T.s and PTAs who experience problems with chemical dependency can find the help and support they need to stay clean and sober without involvement from the Physical Therapy Board of California (PTBC).

Unfortunately, most people suffering from chemical dependency deny the problem. Many times, they are the last to recognize and admit that they need help. If chemical dependency problems are left untreated, they

may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted.

In these cases, it becomes imperative that individuals who detect a chemical dependency health problem in a P.T. or PTA take action. Without intervention, diseases have predictable courses and outcomes. The PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

Licensees are required to provide the Physical Therapy Board of California (PTBC) with an email address if the licensee has one. Email is an efficient conduit for sharing information between PTBC and its applicants and licensees. PTBC will be able to communicate regarding the status of applications, renewals, and requests for various PTBC services; provide law and regulation updates; and disseminate important PTBC news directly to each applicant and licensee—from the PTBC to your door (or email inbox). It doesn't get much easier! The PTBC hopes this accelerated delivery and

exchange of information will decrease processing times in all aspects of the PTBC's programs and facilitate licensees keeping apprised of laws and regulations and PTBC activities. Moreover, with the transition to the BreEZe system, email will be the standard method of communication. You can submit/update your email address using BreEZe or submit your address change with BreEZe. You may also submit your email address in writing to the PTBC—please include your name and license number.

PTBC is eliminating the pocket license

The Physical Therapy Board of California (PTBC) is making license verification more effective and efficient for consumers and licensees. Effective July 2020, the PTBC will no longer issue pocket licenses upon initial licensure or renewal. Pocket licenses may not reflect a licensee's current status as it may change within the two-year license period, and they do not display enforcement action taken against a license, if any. Current license status and enforcement action information is available on Department of Consumer Affairs (DCA) License Search, an online license verification system. Consumers, employers, or any interested party can access license information online 24 hours a day, seven days a week. You can access the DCA License Search system on the home page of the PTBC website at www.ptbc.ca.gov.
