DO WE HAVE YOUR EMAIL ADDRESS?

Licensees are required to provide the Physical Therapy Board of California (PTBC) with an email address if the licensee has one. Email is an efficient conduit for sharing information between PTBC and its applicants and licensees. PTBC will be able to communicate regarding the status of applications, renewals, and requests for various PTBC services; provide law and regulation updates; and disseminate important PTBC news directly to each applicant and licensee—from PTBC to your door (or email inbox). It doesn't get much easier! PTBC hopes this accelerated

delivery and exchange of information will decrease processing times in all aspects of the PTBC's programs and facilitate licensees keeping apprised of laws and regulations and PTBC activities. Moreover, with the transition to the BreZE system, email will be the standard method of communication. You can submit/update your email address using BreZE or submit your address change with BreZE. You may also submit your email address in writing to PTBC—please include your name and license number.

Who is the Physical Therapy Board of California?

The Physical Therapy Board of California (PTBC) is a government agency within the California Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. PTBC provides three principal types of consumer services: verifies education and background prior to licensure, provides information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

Board Meetings

Board meetings are mandated to three board meetings a year. Typically, PTBC conducts four meetings a year in the areas of Northern and Southern California. Board meetings are usually two days long and the public is highly encouraged to attend.

Benefits of Hosting a Board Meeting

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voice heard on topics being discussed.
- Students and applicants can attend in between classes and learn how PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

To advance and protect the interests of the people of California by the effective administration of the Physical Therapy Practice Act.

Vision

The standard for consumer protection in physical therapy.

1. What is your favorite color?

'DELINQUENT, INACTIVE, RETIRED ... OH, MY!'



How to Maintain Your California License if Not Practicing

To practice physical therapy in California, in any capacity or setting, regardless of payment or compensation, a physical therapist or physical therapist assistant licensee shall have a license that is current. But what if a licensee is not practicing either temporarily or permanently? What are the options, if any?

If a license is not renewed by the expiration date, it will automatically enter a **delinquent status**. A licensee in delinquent status is prohibited from practicing. A delinquent license is renewable by completing the renewal application and submitting all outstanding fees. If a delinquent license is not renewed within five years, the license will enter a **canceled status**. A licensee in canceled status is prohibited from practicing. A canceled license is not renewable. If the prior licensee wishes to return to practice in California, a New License Application shall be submitted in accordance with Business and Professions Code (BPC) § 2647. Delinquent and canceled license statuses will automatically occur when no action is taken by the licensee to maintain

the license. However, there are a couple other license status options for licensees who are not practicing, but licensee action is required: inactive and retired statuses.

A licensee who wishes to maintain a renewable license, but is not practicing in California, may request Inactive status at the time of license renewal. **inactive status** requires a licensee to pay the full renewal fee, but the licensee is not required to complete continuing competency hours. A licensee in inactive status is prohibited from practicing. If a licensee wishes to return to current status prior to the expiration date of the license, the licensee shall complete the continuing competency hours required for one renewal and submit an Inactive to Active License Status Application.

If the licensee wishes to return to current status after the expiration date of the license, the licensee is required to complete the continuing competency hours for one renewal and submit the License Renewal Application with all fees, including past

renewal fees if applicable. A license may remain in inactive status indefinitely, but the licensee must take action to renew the inactive status before each license expiration date.

If a licensee is not practicing in California and does not anticipate returning to practice, retired status is available. **Retired status** is not mandatory. A licensee in retired status is prohibited from practicing. If a licensee is no longer practicing in California, the licensee may just cease renewing the license, which will then be delinquent for five years, then Canceled. If delinquent status is not preferrable, a licensee may submit a retired license application with the required fee prior to the expiration of the license. A licensee may not request retired status if the license is in delinquent status; the license would need to be renewed first. A licensee with a license in retired status shall not practice, but because a retired license is still renewable, the licensee remains within the Board's jurisdiction should a complaint or criminal conviction occur. A licensee may restore a license in retired status to current status within five years of the license expiration date by completing continuing competency hours for one renewal, submitting the Restore Retired License to

Active Status Application, and paying the current renewal fee. If a licensee does not restore a license in retired status within five years, the license will remain in retired status and reflect as such when verified through the California Department of Consumer Affairs (DCA) License Search online, but the licensee will need to submit a new license application in accordance with BPC § 2647. New retired license status regulations that include the requirements identified above were adopted by the Board and took effect January 1, 2023. See the article on page 26 on newly adopted regulations for additional information.

Reminder: All renewable license statuses, even if practice is not permitted, remain within the Board's jurisdiction. Therefore, licensees with these statuses shall maintain name and contact information with the Board pursuant to CCR § 1398.6.

While this article specifically addresses statuses for licensees not practicing, here is a quick reference guide.

License Status Quick Reference

DELINQUENT	NO PRACTICE PERMITTED. LICENSE MAY BE RENEWED BY SUBMITTING ALL PAST DUE RENEWAL FEES AND A COMPLETED LICENSE RENEWAL APPLICATION FORM WITHIN FIVE YEARS OF EXPIRATION DATE.
CURRENT—INACTIVE	NO PRACTICE IS PERMITTED. LICENSE MAY BE PLACED IN CURRENT "ACTIVE" STATUS BY COMPLETING CONTINUING COMPETENCY REQUIREMENTS AND SUBMITTING COMPLETED INACTIVE TO ACTIVE LICENSE STATUS APPLICATION FORM TO PTBC.
CANCELED	NO PRACTICE PERMITTED. LICENSE WAS NOT UPDATED WITHIN FIVE YEARS OF EXPIRATION DATE AND IS NOT RENEWABLE. TO PRACTICE IN CALIFORNIA AGAIN, A NEW INITIAL LICENSE APPLICATION MUST BE SUBMITTED.
MILITARY—ACTIVE	ACTIVELY SERVING IN THE MILITARY AND PRACTICE IS PERMITTED ONLY IN A MILITARY SETTING. NO PRIVATE PRACTICE IS PERMITTED.
MILITARY—INACTIVE	ACTIVELY SERVING IN THE MILITARY. NO PRACTICE IS PERMITTED.
RETIRED	NO PRACTICE PERMITTED. IF NOT CHANGED, RETIRED STATUS WILL REMAIN IN EFFECT FOR FIVE YEARS FROM THE EXPIRATION DATE. THEN, THE LICENSE WILL CANCEL.
PROBATION (SECONDARY STATUS)	DISCIPLINARY DECISION THAT INCLUDES A PROBATIONARY PERIOD WITH TERMS AND CONDITIONS AS OUTLINED IN THE DECISION.
SURRENDER	NO PRACTICE PERMITTED. DISCIPLINARY ACTION TAKEN BY PTBC; LICENSEE SURRENDERED LICENSE.
SUSPENDED	NO PRACTICE PERMITTED. SUSPENSION DUE TO DISCIPLINARY ACTION TAKEN BY PTBC.
REVOKED	NO PRACTICE PERMITTED. LICENSE REVOKED AS A RESULT OF DISCIPLINARY ACTION TAKEN BY THE BOARD.

SUBSTANCE ABUSE REHABILITATION HOTLINE



Physical therapists (P.T.s) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10% of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including P.T.s and PTAs, may be particularly susceptible to substance abuse problems due to the stresses of working in a health care environment and an increased opportunity to obtain controlled substances.

Many P.T.s and PTAs who experience problems with chemical dependency can find the help and support they need to stay sober without involvement from the Physical Therapy Board of California (PTBC).

Unfortunately, most people suffering from chemical dependency deny the problem. Many times, they are the last to recognize and admit they need help. If chemical dependency problems are left untreated, they

may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted.

In these cases, it becomes imperative that individuals who detect a chemical dependency health problem in a P.T. or PTA take action. Without intervention, diseases have predictable courses and outcomes. PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

PTBC HAS ELIMINATED THE POCKET LICENSE

The Physical Therapy Board of California (PTBC) has made license verification more effective and efficient for consumers and licensees. Effective July 2020, PTBC no longer issues pocket licenses upon initial licensure or renewal. Pocket licenses may not reflect a licensee's current status as it may change within the two-year license period, and they do not

display enforcement action taken against a license, if any. Current license status and enforcement action information is available on the California Department of Consumer Affairs (DCA) [License Search, an online license verification system](#). Consumers, employers, or any interested party can access license information online 24/7. You can access the DCA License Search system on the home page of the PTBC website at www.ptbc.ca.gov.







- **Clinical Service Requirements for Foreign Educated Applicants—Effective May 9, 2023**

Amends section 1398.26.5 of Article 2 of Division 13.2, title 16 of the California Code of Regulations.

This regulation allows for the use of the Federation of State Boards of Physical Therapy’s (FSBPT) Supervised Clinical Performance Evaluation Tool (PET), as an alternative to use of the American Physical Therapy Association’s (APTA) Clinical Performance Instrument (CPI). Additionally, the amendments make non-substantive changes such as replacing the word “credentialed” for “certified” in reference to the clinical instructor. This is consistent with APTA’s terminology and adds clarity to the regulation, since it eliminates confusion between the clinical service being certified and the clinical instructors being certified. This regulation also corrects a typographical error in subsection (d) by replacing the word “elevations” with “evaluations.”

- **Retired License and Fees—Effective January 1, 2023**

Adds section 1398.18 to new Article 1.5 and amends sections 1399.50 and 1399.52 of Article 10 of Division 13.2 of title 16 of the California Code of Regulations.

This regulation establishes minimum eligibility requirements to enter into Retired license as well as defines requirements for restoring a license to an Active Status should a licensee with a

Retired license choose. These regulations will also incorporate by reference the application to enter retired license (RS1 [NEW 09/2021]) and the application to restore a Retired license into Active Status (RS2 [NEW 09/2021]). Additionally, this rulemaking amends sections 1399.50 and 1399.52 to set a one-time \$100 application fee to enter into Retired license.

- **Satisfactory Documentary Evidence of Equivalent Foreign Education for Licensure as a Physical Therapist or Physical Therapist Assistant—Effective January 1, 2023**

Amends section 1398.26.1 of Article 2 of Division 13.2, title 16 of the California Code of Regulations.

This regulation includes tools for evaluating current education equivalency of those graduates from a non-accredited foreign physical therapy program and authorizes the Board to accept Coursework Tool (CWT) 6, in lieu of the corresponding CWT 1–5, and authorizes the Board to accept the Coursework Tool for Physical Therapist Assistants (PTA Tool 2) for all years of graduation from non-accredited foreign schools.

Glossary of Terms

Accusations: Charges filed against a licensee alleging violation(s) of the Physical Therapy Practice Act.

Interim Suspension Order: An Order issued upon petition, suspending a licensee from all or specified part of their practice of, or assisting in the provision of, physical therapy.

Petition to Revoke Probation: Charges filed against a probationer seeking revocation of their physical therapy or physical therapy assistant license based upon violation(s) of probation.

Probationary License: Where good cause exists to deny a license, the licensing agency has the option to issue a conditional license subject to probationary terms and conditions.

Public Letter of Reprimand: In lieu of filing a formal accusation, the Board may, pursuant to B & P Code section 2660.3, upon stipulation or agreement by the licensee, issue a public letter of reprimand. If the licensee does not agree to the issuance of the letter, the Board shall not issue the letter and may proceed to file a formal accusation. A public letter of reprimand is considered disciplinary action.

Statement of Issues Filed: Charges filed against an applicant due to alleged violation(s) of the Physical Therapy Practice Act. If found to be true, the charges may result in discipline.

Surrender of License: The licensee surrenders their license to the Board, subject to acceptance of the surrendered license by the Board, and the licensee is prohibited from engaging in the practice, or assisting in the provision, of physical therapy.

Stipulated Decision: Negotiated settlements waiving court appeals.

ADMINISTRATIVE ACTIONS—CITATIONS



A Citation and Fine is an administrative action by which the Physical Therapy Board of California may address relatively minor violations of the Physical Therapy Practice Act that would not necessarily warrant discipline in order to protect the public.

Citation and Fine Orders are not disciplinary actions but are matters of public record. Citations remain on a licensee's file for five years and are then purged. By law, payment of a fine is considered satisfactory resolution of all violations contained in the citation.
